I refer to Council's letter of 6 May 2004, and our response on 31 May 2004, and our subsequent telephone conversation with Cheryl Gibson on this matter. I also note that Pauline Deveson has spoken to Andrew Conochie of our office in relation to a Survey Plan currently bring sealed by Council.

We are asking for your consideration, to allow the additional \$14,489.89 rates amount be waived on the following grounds –

1. Sunland (Carnriver) did not receive Council's rates notice until after the discount period, as it was delivered to Level 18, 50 Cavill Avenue Surfers Paradise and not our postal address of PO Box 1301 Surfers Paradise. We relocated from Level 18 to Level 14 in February 2003, which unfortunately made it even more difficult to obtain the notice.
2. We normally receive Council correspondence to our PO Box address, including rates notices for all other properties.
3. The Sunland Group have always paid their rates notice prior to the discount date.
4. The Sunland Group currently undertake a large number of projects on the Gold Coast and have done so over the last ten plus years, which would have equated to hundreds of thousands of dollars over the years. We have never asked the rates section for a consideration like this before as we have always paid on time.
5. The Sunland Group use Council for all our building certification of highrise and houses which ~~adds~~ ^{amounts} to quite a large sum of money each year.

We therefore request that you reconsider ^{our} previous decision and waiver the outstanding amount of \$14,489.89 plus any interest incurred to date.

I refer to your letter dated 18 June 2004 requesting granting of Council's discount allowance.

While I appreciate the circumstances outlined in your letter, Council is bound by the provisions of Local Government Act when considering applications for discount allowance. Unfortunately, the circumstances resulting in the late payment do not fall under these provisions and Council is required to show impartiality towards all ratepayers when assessing applications such as these.

In light of the above, I regret to advise that in this instance discount cannot be allowed.

As your original enquiry regarding this matter was received in March 2004, all interest charges that had accrued have now been withdrawn (\$667.44), resulting in only the original discount amount of \$13,822.45 remaining outstanding.

Council has also extended the due date of this outstanding balance to 14 days from the date of this letter. In order to avoid the imposition of any interest charges, it is recommended that full payment of \$13,822.45 be received no later than 6 August 2004.



In reference to the ongoing dispute on the above rate notice, I am the Receptionist for Sunland Group and I am responsible for the incoming mail. We receive our mail by courier each morning who clears our Post Office box at Surfers Paradise, I also check once or twice a week the mail trays located on B1 of our building, 50 Cavill Avenue. Our company like other companies within the building hold a box on B1 which is labelled Sunland Group.

Over eighteen months ago we were located on Level 18 of 50 Cavill Avenue, of which there is a tray on B1 labelled level 18, this is shared by the 3 companies located on that floor. Falcon Group, Platinum Finance & Charters Pacific, they also hold postal boxes. The boxes and trays that are located on B1 are in open viewing in the carpark, it is not a secure environment.

Quite often when I go down to check our mail, I will grab all mail addressed to Sunland level 14 and mail for level 18, I will then proceed to go through it when I am back at my desk, as we have many different company names. What mail is not ours I will take down next time I go and place on top of the boxes on B1.

I always take a copy of rates and letters from the Council that are addressed to our street address and fax to 55816 346 with street address crossed out and our postal address written in. You may like to check this out with the section that would receive it to confirm that I do this.

There could be many reasons why this document went astray, I spoke to each receptionist for these companies located on level 18, except for Charters Pacific as they have never used B1, these ladies basically do what I do, take the mail and sort out what is theirs and take the remainder back at a later time.

I feel that this is what has happened and I am astonished that the Council would query our explanation as to why this was not paid on time. I have worked with Sunland for 5 years and I can say without question that Sunland would not hesitate to pay the full amount if the delay was due to negligence of a staff member to pay on the due date.

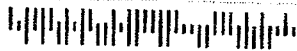

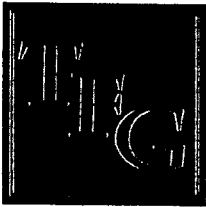
