70 KB Type documents up for Tony?

72 SW Yes I type documents - we do a lot of emails now. Not a lot of emails for the staff but

148 KB As that date appears on a covering letter signed by Mr Hickey relating to the document.

152 KB Do you agree with that?

183 KB So what you're saying in relation to this trust account statement that was forwarded to the  
184 CMC during April 2005 it was initially scanned from another document is that correct?

186 SW Yeah, yes.

188 KB And I'll come back to that a little bit later. But can you tell me whereabouts it was  
189 actually prepared? Where you prepared this document after it was scanned?

228 KB So this is quite important. Can you recall the actual words that he used in order for you to  
229 prepare this document? What he said?

231 SW He just said that we need to repair - prepare a report and - of everything on this file from  
232 day one from the very beginning of the file anything that we got in and anything that went  
233 out because that's what this guy wanted.  
234  
235 KB From the CMC?  
236  
237 SW Yeah sorry, sorry from the CMC. He wanted a report of everything that had gone in and  
238 out of our trust account from the start to the finish.  
239  
240 KB When you say trust account what was the name of that trust account?  
241  
242 SW The Li - well it was - there was two files. There was one file that was opened initially  
243 and that was umm David Power and umm Susan Robbins. Now I can't remember exactly  
244 the name of it but anyway it was opened under their names first okay and then it - it was  
245 changed to Lionel Barden so a new file was opened and that file was made a dead file.

247 KB Do you know why the names were changed from Power and Robbins to Lionel Barden?

259 what I did.

261 KB So it wasn't the case that you picked up that it was a different account name as opposed to  
262 the Power and Robbins account?  
263  
264 SW No because when, when you've got a file and it's gotta go under a different name that gets  
265 closed - that's our procedure here. That gets closed and we open a brand new file with  
266 that - with whatever re it is that's been changed to. In this case it was this person called  
267 Lionel Barden.

269 KB You mentioned before that the document was scanned...

277 KB Can you just outline how that procedure works. So let me give you a hand.

298 printed them off her machine and brought them down to me and then I typed my report  
299 off that.

301 KB Alright. So after Mr Hickey asked you to prepare this document...
