
A concerns notice has been sent to Mr Duffy in relation to some of the more serious claims he has made. Please find a copy of this Concerns Notice enclosed.

We wish to alert you of this as Mr Duffy has now nominated for Mayor of Ipswich and may therefore be in violation of certain rules surrounding the conduct of candidates during an election. This may include a violation of Section 102 of the *Criminal Code Act 1899* (Qld) relating to "Publishing false information about a candidate".

Accordingly, our client now makes a formal complaint against Mr Duffy and asks that you conduct a full and thorough investigation into this matter.
