I have completed many courses that include small business, occupational health and safety.

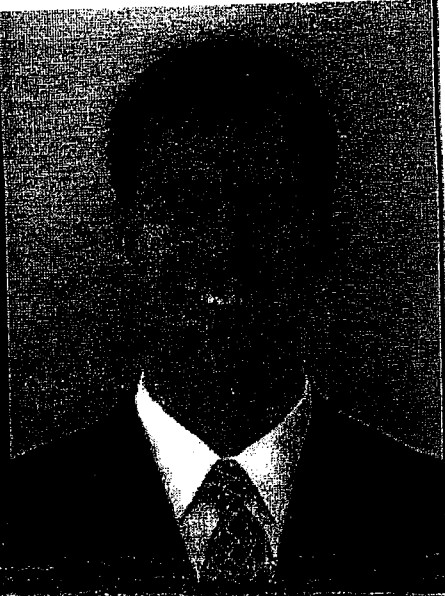
