4 meeting with Chris Morgan or any other representative from Quadrant or if her father had

12 KB No good there obviously. Same response as yesterday got the answering machine.
13 Already left a message on that. Will try the mobile number 0408 250 364 see how we go
14 this time.

18 KB Doesn't look too promising. The mobile phone is ringing out by the sounds it but we'll
19 let it ring out. Didn't switch over to message bank yesterday. Doesn't look like it's
20 going to do that today either.

24 NC [ui] can I help you.

26 KB Yeah hello I was after Niree thanks.

27
28 NC It's Niree may I help you.

55 NC Now I, I, when, when they - I don't even know who mentioned it to me. I really don't. I
56 was just - we were talking about you know the elections in - at work.

58 KB Okay
59
60 NC I might have been one of my work colleagues but umm I'm thinking that it was - I, I have
61 heard the name before and it rings a bell and I'm trying to think of how because I don't
62 recall having anything to do with anything from Quadrant.
63
64 KB Did you ever contact any person from Quadrant at all?
65
66 NC I don't know anyone from Quadrant. If you can tell me where, what they are and who
67 they are that might be better and then umm it could help me out a bit.
68
69 KB Alright what about if I mention the name Chris Morgan to you from Quadrant. Do you
70 know a Chris Morgan at all?
71
72 NC Ohh umm the name's not ringing a bell but the company rings a bell. When someone
73 brought it up to me the other day 'cos they were sitting there talking about - they were

86 meeting with one person and I don't know his name because it was such a brief meeting
87 and then we left.

89 KB What was that meeting about Niree do you know?
90
91 NC Umm yeah I do know umm we were actually -- when we were umm campaigning umm it
92 was for, someone was going to give us some funding but we never ever ever got any
93 funding umm but we were approached and that was about it and I just -- my father said
94 ohh we're not interested and that's about it and.
95
96 KB What was that funding for can you recall or?
97
98 NC Ohh it was just -- it would have been for our campaign but we never, we never got any.
99 My Dad was with me. My Dad might know the persons name 'cos I personally it was
100 such a quick meeting and I don't know if it was with Quadrant or not.

102 KB Can you recall where the meeting was?
103
104 NC Yeah it was at Robina.

106 KB Was it in an office at Robina?
107
108 NC Yeah

110 KB Was it at...

112 NC But I don't recall the, the name.

116 NC [ui] this is what blew me apart the other day when I was speaking.

137 someone.

139 NC It was in a morning and that was it and umm then we never ever spoke to that person ever
140 again and we never received any money.

142 KB And why, why did you have the meeting with this person again?
143
144 NC It was over – something to do with – someone was going to umm I don't know something
145 about funding had approached us or something and that was about it and 'cos my Dad
146 says no we're right we, we don't need any funding.
147
148 KB Do you know who that person may or persons may have been that ahh told you about
149 meet with this ahh particular person and you'd receive some funding? Do you know who
150 told you to go there?
151
152 NC Ohh gawd! [*her emphasis*] Umm ohhh umm I know I spoke to umm umm Bob.

154 KB Bob – who's that?

156 NC Bob La Castra

158 KB And he may have informed you to go to this place at Robina and you may receive some
159 funding?

162 just a feel – no, no, no because we never – because we were a completely independent
163 and didn't do, you know, we weren't going with anybody else umm and I have a feeling
164 that's why we copped a lot of flack because we didn't do anything with anybody umm
165 and we – I don't even know how – I swear Ken I have no idea how it even arose. But we,
166 we did go to a meeting at umm umm Robina at Corporate – whatever that place is – but
167 Corporate Park's near the kindy I think isn't it?

169 KB Ohh look I'm not sure if that's the exact title of it.
170

171 NC But it was off Glenferrie, it was off Glenferrie. You know why I know where – I don't
172 know the name of the actual park but I know it's off Glenferrie the reason I say that is
173 because umm Queensland Education's in there.

177 NC Education Queensland in there and I, and that's why I hadn't even thought about it
178 because I had been to Queensland Education quite a few times you know for ahh as a
179 umm what do you call when I was – as a community representative for Principal Meeting
180 and things like that.
181

182 KB Yes

184 NC So I really do apologise for that but I had – it really didn't even enter my mind until
185 someone said something about Quadrant. I said geez I know that name.
186

187 KB So you think it may have been Bob La Castra that suggested you go there?
188

189 NC Ohh well yeah because I mean, I, I've met Bob a couple of times too and ahh but we
190 never – I never ever received any funding. My Dad'll tell – I'm sure...
191

192 KB Sure

194 NC ...I don't know the person's name and I'm sure that you can ask my Dad as well.
195

196 KB Was Bob like a mentor to you at all? Bob La Castra – would you describe him as that?
197

198 NC A mentor – now – I would consider maybe one of my professors at Uni a mentor.

202 NC Ahh but I don't – after those elections and I don't – I don't think any of them are capable
203 of being mentors.

207 NC Ahh maybe I, I think – I, I would honestly think that – ohh no I wouldn't consider him a
208 mentor I, I – considering I had only just sort of met him umm then I think, I, I, I just
209 believed he was just being ahh a person that was being – just a friend that's all. I
210 honestly that's all. I don't consider him a mentor. I don't consider any of them because I,
211 you know, I just don't trust any...
212
213 KB Before you umm can you recall before you attended Glenferrie Drive there the office ahh
214 there for this meeting, can you recall you ahh making a phone call at all to any person
215 there? Like to arrange a meeting, to arrange a time for the meeting?
216
217 NC Ohh ohh no I can't to be – I really can't. I was flat out rememb – I didn't even know
218 because I didn't – the thing that gets me is I didn't think – didn't even remember
219 Quadrant until someone brought it up in the office the other day because we were
220 discussing – actually we were discussing it over lunch and umm here at work and I didn't
221 even remember that. So I didn't even – I sent off all these forms to the MC whatever it is
222 – Misconduct Commission and umm I didn't even write Quadrant 'cos I actually wrote in
223 everything else. I sent a 3 page letter saying I knew – I had met Bob La Castra. I knew
224 Jan Grew 'cos she's studying in my class the whole lot.
225
226 KB I can inform you that ahh Quadrant do provide ahh part of the services they provide is
227 connected with advertising.
228
229 NC Yeah no – you know what we got all my stuff was all through Mudgeeraba Printing.
230
231 KB Right
232
233 NC You can check all of that. That was all through my Dad's funds. Paid with a cheque. He
234 did our distribution through – there was some umm ahh my Dad would know because he
235 would have the, the ahh amounts and that umm for some like pamphlet distributor at
236 Southport near Jackson Street area.
237
238 KB Yeah
239
240 NC And umm no I didn't have any – everything was self – I could swear on a Bible on that
241 one.
242
243 KB That's fine. You sure you can't recall this person Chris Morgan?
244
245 NC I don't – ahh I know it was a man but I don't know his name.
246
247 KB Can you describe him for me?

249 NC I can't even do that. I could not tell you if he was blonde or grey because I only ever met
250 him once and that was it.
251
252 KB But you went there – just so I've got it right – you went there.
253
254 NC Ohh I did, I did go to umm I don't if the business was called Quadrant and ahh because
255 that just rings a bell but I really don't – I could not tell you the gentleman's name. I
256 couldn't even tell you what he looked like. Umm and I'm, I'm a real face person so I'll
257 remember people's faces but – and I'm usually good with names but I had not even
258 remembered Quadrant.
259
260 KB Okay but you went there as a result of what Bob La Castra suggested to you it might be
261 worthwhile going there in relation to funding I think you said earlier on.
262
263 NC Yeah well I mean and, and to be quite honest I, I, I believe that Bob did that in the best
264 intention in case – just in case we could get extra funding for the campaigning but it
265 would have all been declared because that was all above – as far as I was aware
266 everything was above board. We never ever – we never went back to them. We never
267 received anything and you know I am positive Bob will say exactly the same thing
268 because I have never – I haven't spoken to Bob since. I don't think I've spoken to Bob
269 since the end of the election. Umm
270
271 KB Was there any – for the funding was there anything specifically that you were going to
272 use the funding for if you had of received it?
273
274 NC Ohh well it would have been to advertise I presume in the – I dunno – we didn't – you
275 know what because we never ever did anything we never took it we – you know what it's
276 such a umm a grey question like I know it sounds really basic but because we never ever
277 received any we didn't have to even consider what we were going – you know what I
278 mean?
279
280 KB Yeah
281
282 NC It was pointless. My Dad just – I remember my Dad turning around and saying well we
283 don't really need that we're fine.
284
285 KB But in any event you didn't receive any funding from Quadrant?
286
287 NC Ohh no. We never received a cent from anybody. That's why I think – like we had my
288 parents friends are in their 60's come down and walk around and some umm all my
289 family and my husband and we went and did letterbox drops. No if we had – no not a
290 cent.
291
292 KB But, but it's possible you spoke with someone from Quadrant to arrange a meeting?

295 really cannot remember ringing. Maybe I did but umm I know I had a meeting there and

311 KB I'm not talking about just funding but any services? Any advertising services or any
312 other services?

316 KB No?
317
318 NC The – what's – I think [ui] Steve Page did all my – I wrote my all my own things umm for
319 the leaflets that we did. Umm Linda and Steve Page whom I've used on numerous
320 occasions for the school when I would do news umm what do you call them ahh year
321 books. Umm I've know Linda and Steve for a long, long, long time.
322
323 KB That's sorry Linda and Steve from?
324
325 NC Page. They own Mudgeeraba Printing.
326
327 KB Right
328
329 NC That's a local printer when we used to live out at Mudgeeraba and I've used them over
330 time for many things. It was to me that we went to them was natural and I wrote my own
331 things and they did all the umm printing. Never any money for anyone else and I never
332 used anybody else.
333
334 KB Can I just umm put an email to you? This is an email that ahh we have and that's why I
335 just wanted to, to gauge your independent recol – excuse me – recollection first. But
336 umm it's from a Chris Morgan and I can tell you now that Chris Morgan is attached to

344 NC Well that was just prior to the election yeah.
345
346 KB Yeah and he sent it to Sue Davies who was the PA to the late Brian Ray okay and he's
347 got here ahh "Hi Brian ahh Niree Christison just called and meeting with her in her
348 campaign manager 9:00 am Monday next February 9 at Quadrant" so the 9th of February
349 at Quadrant. I understand this is a "tell me what you think" appraisal with no immediate
350 commitments. Anything further I should be aware of could you please advise. Regards
351 Chris Morgan"
352
353 NC That's okay look I never ever ever met Brian Ray in my life.
354
355 KB Yeah
356
357 NC Umm it's funny you should say that because I have never umm look I know where he
358 lived on Hedges and the funny thing was I had a lovely gentleman that was like his
359 neighbour like two down. His name is Allan and his wife is Shelley and they put one of
360 my signs in their front yard and umm umm and umm sorry I've got get off to training...
361
362 KB Yeah you're right I won't keep you much longer anyhow.
363
364 NC ...now you can ring me back later on if you want like 'cos I just have to be in training but
365 umm...
366
367 KB Yeah
368
369 NC ...the thing is that umm what'd you call it umm he had it in his front yard and then people
370 said to umm Allan and – I'm sure they said to Allan – but it was mentioned to me too that
371 umm people pulled out – pulled signs out – you can actually ask Allan – pulled the signs
372 out of his front yard. Pulled signs out [ui] because they believed I had umm funding with
373 [ui]. I didn't even know he lived there at that stage.
