Karel Alexander WEIMAR states:-

1. I am a Certified Practicing Accountant (CPA) and I hold a Bachelor of Business degree from the Queensland Institute of Technology (1985) and a Master of Commerce degree from Griffith University (2000). I am a member of CPA Australia and I have been a CPA since 1998.
2. I am a Principal Financial Investigator employed by the Crime division of the Crime and Misconduct Commission (CMC) and I have been employed by the Commission as a Financial Investigator for seven years.
3. In August 2005, I was assigned to an investigation into complaints relating to the Gold Coast City Council.
4. As part of that investigation, I have examined Local Government Election Gifts forms provided by the Gold Coast City Council and I have previously provided a witness statement in regards to the analysis of these returns.
5. I have compared the electoral return submitted by Councillor David Power to the copies of documents provided by Councillor Power in response to a CMC notice to discover.

6. In particular, I have compared amounts declared as gifts by Councillor Power to amounts deposited to Councillor Power's campaign account – an account held at the national Australia Bank in Beenleigh and titled "D Woods as trustee for Power Campaign Committee".
7. I have reproduced the details of monetary gifts included in Councillor Power's electoral return and the actual deposits to the campaign account in the attached spreadsheet.
8. Councillor Power has declared that he received \$88,925 in electoral gifts from 486 persons. The total gifts declared of \$88,925 includes \$87,825 in cash donations and \$1,100 of donations in kind. Deposits to the campaign account total \$87,950 – a variation of \$125 on the amount declared.
9. I have determined from documents provided by Graeme Ingles of the Ingles Group (Qld) Pty Ltd that Councillor Power's campaign committee had a fund raising luncheon on 03 March 2004. Councillor Power's return states that sales of "various luncheon tickets" totaled \$58,000 and that amount corresponded to 469 persons.
10. The invitation sent to Graeme Ingles states that tickets cost \$125 per person. The invitation also asked that invitees respond to the invitation by 01 March 2004 indicating how many were attending at a cost of \$125 each or, alternatively, enclosing a donation if unable to attend.
11. Given that responses, (enclosing a cheque payment), were required by 01 March 2004, I would expect that all cheques for ticket purchases and/or donations would have been banked by 04 March 2004. Instead, it appears from the attached spreadsheet, that money for tickets continued to be deposited to the campaign account until 05 April 2004.
12. In the period following the day of the fund raising lunch, from 04 March 2004 to 05 April 2004, an amount of \$7,375 was collected in luncheon ticket sales.
13. As part of my inquiries, I have been to the Windaroo Lakes Golf Club, spoken to the manager and seen the function room at the club. The function room can comfortably hold about 250 people for a "stand up" lunch and down to about 150 for a "sit down" lunch.

14. The current manager has stated that all of the records relating to the date of the function have been destroyed without her approval when the club started expansion of facilities and the building where the records had been housed the records was destroyed (along with the records) when the site was being cleared.
15. However, in relation to club takings on 03 March 2004, the club's daily cash summary report is still on hand and that report shows that there was a function on 03 March 2004 and food totaling \$2,475 was charged for that functions and \$668 worth of alcohol was sold. Based on the club's menu prices, a stand up lunch involving "finger food" may be as little as \$6 per head up to \$28 per head for a 2 course lunch.
16. Without access to the records, there is no way to determine exactly how many people attended the function for Councillor Power on 03 March 2004.


