**Submission to the CMC: Review of Queensland's police move-on powers.**

Below I set out details about my personal experiences with move-on powers and my comments about their use and effect. I have also supplied my personal details and request that you keep my identity confidential.

**A. I have had the following experiences with the move-on powers:**

**EXPERIENCE ONE**

**1. I was asked to move on (approximate year/month/time of day):**

End November 2008, 6pm

**2. At the time I was asked to move on I lived:**

- Sleeping rough
