I am writing an important submission for the Prostitution act review 2010/11. Please do take the following into consideration for a needed and desperate but simple change in the brothel aspect of the prostitution act.

I thank you for your missions and goals for the industry in QLD and we all strive together to keep the industry clean and palatable for the community, as well as keeping the best interests of the community at large and individuals in the adult industry in regards to health and conduct.

The prostitution act for Qld brothels as it is at present: We can have <u>not more than</u> 8 service providers operating at one time....However.....we can have <u>not more than</u> 5 rooms for the ladies to operate out of. *This is very frustrating!* 

I even have heard on a radio program.... They were ridiculing the fact that how can a brothel in Qld allow 8 service providers to operate at one time and only have 5 working rooms... Well, after a chuckle, they correctly say - "you figure that one out."

Well, to be honest... I feel very sorry for the service providers.

This is a real true scenario of what happens in a Qld brothel. 8 service providers will turn up for their shift at a brothel... Customers come to the door. The girls do their introductions.

1 lady gets picked... off they go to room 1... then next customers., 2 mates .. next 2 ladies get picked.... off they go to rooms 2 and room 3.... then the next customer picks a lady... off they go to room 4... then 3 mates come in. the remaining 4 ladies introduce themselves. The 3 mates choose 3 of the ladies, the ladies are so encouraged ....but one big problem.... only 1 working room left. ok. so... what do we do.... one lady takes one mate to room 5 and the other 2 have to wait up to half an hour or maybe an hour for a room to be vacated and cleaned.

Then there is the 8<sup>th</sup> lady.... She is the one that is pretty... but not as pretty as the others.... slim....but not as slim as the others....

Well. By the time her chance comes around, 2 or 3 of the stunning ladies are back for more customers..... so poor little 7<sup>th</sup> or 8<sup>th</sup> lady sometimes goes all night without a customer or perhaps only 1 customer..

This is very discouraging and has caused debilitating depression and mental health issues.

In the mean time... there have been more customers come to the door. "Sir, there will be about a half an hour or more wait... that is for a room" SO MISTER CRACKEDAFAT WOULD HAVE STAYED TO SEE MISS 7<sup>TH</sup> OR 8<sup>TH</sup> GIRL....IF THERE WAS A WORKING ROOM FOR HER. But.....no... he couldn't wait for the room, So he left.

Dear CMC. This happens every day and especially on weekends at QLD brothels.

## PLEASE HELP - WE NEED 8 WORKING ROOMS IN QLD BROTHELS.

Is it not too much to ask that you please sanction the operating of 8 rooms for the 8 service providers on shift at one time at a legal brothel in Qld.

Thank you for listening. I wish for the ladies sake that you please allow the brothels to have 8 rooms.
