RE: DONATION- LOGAN COUNCIL ELECTIONS 19 MARCH 2016- CR LUKE SMITH- LOGAN FUTURES PTY LTD

I am an independent director of Logan Futures Pty Ltd ('the company').

The company was established to be the entity through which the Mayoral candidate for Logan, Cr Luke Smith, administered his election campaign. The company received all donations, recorded banked and administered them, and has filed a prescribed electoral commission return disclosing all donations received in accordance with the *Electoral Act 1992* and *Electoral Regulation 2013*.

During the campaign the company received from you or entities associated with you a total of \$63,300. In the Electoral Commission Return filed by the company the company disclosed the full amounts of all these donations. In addition, based on your instructions, the donations were recorded as having been received from 'Australian Yues International Development Group'. This entity was recorded on the Electoral Commission Return as the donor to comply fully with the legal obligations of the company.

We have since discovered that there is no legal entity by the name 'Australian Yues International Development Group' that had legal status at the time of the donations. It may well be case that you refer to your companies as a 'Group' and there may be several entities registered at law with the name 'Yues' in their title hence the reason why you have asked as to record a 'Group' entity in the fashion you have.

The company was not aware of these matters at the time of the donations and it is the preference of the company to record an entity/person that has legal status (ie an incorporated company or an individual) as the donor.

This matter, as you are aware, did receive attention in the press recently.

To continue to be as transparent as the company can we wanted to afford you the opportunity to advise us the lawful entity associated with the donation so that we may amend the company return

if necessary. In addition we would encourage you to file your own return in accord with the *Local Government Electoral Act 2011 s123-125*.

I would appreciate your response in the next 7 days.
