	CA	Successfully contested elections in 2012 and 2016?
10	W	I started in 1994 at Redcliffe.
	CA	Yes. You were the Mayor of Redcliffe at one time, before the amalgamation?
	W	Yes, that's correct.
	CA	You are appearing today in response to an attendance notice?
	W	Yes.
	CA	Can I just show you that.
• •	W	Yes, sure.
20	CA	Is that a copy of the notice you were given to attend today, Mr SUTHERLAND?
	W	Yes, be it that we're Friday now and not Wednesday.
	CA	Yes, true. I tender that.
	PO	Exhibit 67.
30	CA	Are you a member of a political party, Mr SUTHERLAND?
	W	No.
	CA	Have you been?
	W	In the '90s, the first half of the '90s.
40	CA	Have you been a member of any party whilst you've been Mayor of Moreton Regional Council?
40	W	No, not Moreton nor Redcliffe. I haven't had any political involvement with any party for almost two decades, I'd say.
	CA	Do you campaign as an independent?
	W	Absolutely.
	CA	What does that mean to you?
50	W	It means that I have no political master, neither Labor or Liberal. I just don't have to answer. It gives me a lot more freedom, as a Mayor, to be able to talk to state or federal colleagues, whether they be, as we've got at the moment, a state Labor Party and an LNP federal government, and I have to have dialogue with all, as we did in many discussions that we've had over the years with things. I've worked across all tiers of government of all political persuasions, and it means a lot to me to keep my

	CA	Candidates for local government elections are not party endorsed, are they, at least not in Moreton?
	W	No.
10	CA	But some may over time have memberships of parties or other obvious signs of political affiliation?
10	W	That's true, as we have in Moreton Council at the moment.
	CA	I think it's your view, is it not, that voters don't want party-endorsed candidates?
	W	Well, I'm sure voters don't want politics, be it of any persuasion, running their councils.
20	CA	Why do you say that?
20	W	Why do I say that?
	CA	Mmm.
30	W	I think local government's parish pump politics. It's closest to the people. I think it would be a fair comment to make that over the last decade or two, there has been disillusionment with all levels of government, particularly state and federal, and perhaps, depending on who the government is, with different governments. I don't think people want to see party involvement in their local councils.
		I have no objection to people belonging to political parties. We've sat with members of different political parties in my council, or our council, ever since it was formed in 2008 and my message is clear: keep your politics at the door.
	CA	So candidates do not have party funding for their campaigns?
40	W	Not that I'm aware of, no.
40	CA	You don't approve, either, do you, of unions supporting candidates financially?
	W	No, I don't. No.
	CA	I know you gave an example of that when you were interviewed by the Commission investigators.
50	W	I have some examples here.
50	CA	We probably don't need to go to them, but is it fair to say that you don't support party funding for candidates?

Well, no, not - I guess the issue arises that the people don't know. And

I think we had a perfect example in the last election, when people found out that a person was supported by a union in a fairly major way. It

CA Yes, okay. Candidates have to rely on their own resources or fundraisers or donations or a combination of it?

It depends on the size of the council. In the old Redcliffe Council, when I joined in '94, to the best of my memory virtually all of my campaigns were sole funded. And the mayoral campaign, I had some family support. I can't recall whether I had other support at all then, and I funded it myself. But we were looking at an area the size of two divisions of Moreton Bay Region.

Moreton Bay Region now encompasses three federal electorates and some eight shared state seats. It's the third-largest council in Australia. To give an example of funding, I've got two letterbox drops here. The postage for those was around the 45K mark -- two drops.

CA A big impost on a candidate to fund their own campaign, is it?

W It's a \$200,000 exercise, minimum.

CA That's at your level; correct?

W Mmm, yes.

CA But for the average councillor, less than that or not?

Depending on the councillor. If you were someone like Brian BATTERSBY, who was there for 40-odd years, he could probably do it on tuppence, he was so well known. If you were new to the fold and you didn't have a name and you had to establish a name, I suppose upwards to a polished, professional campaign, maybe \$35,000 or \$40,000.

CA So did I sum it up correctly that candidates need to rely on personal funding, fundraisers or donations?

W Yes, I'd say that would be correct.

CA You described that as terrible, I think, a moment ago. Why do you say that, Mr SUTHERLAND?

W It's the worst part of your job as a Mayor or a councillor. No-one likes it. I've never spoken to any Mayor anywhere at any time that likes fundraising activities. If you can pick a worst part of your job, that would

be it. It's not pleasant.

CA Is there a better model, the Commission would be interested to know, in this context?

W Well, I think there needs to be changes, yes.

CA Do you have any suggestions?

I've got a lot of suggestions. I don't know whether we're in the environment to make them. I think there should be caps.

CA I beg your pardon?

There should be caps on the amount of donations. The public, quite rightfully, do get suspicious of donors, for different reasons. I guess - I made a prediction in 2008 that I would be - I was the last Mayor of Redcliffe and I think - I made a prediction that I'm possibly the last independent Mayor of Moreton Bay Region.

And I say that because when it comes to funding, if we don't allow some funding somehow, particularly for mayoral candidates in the large amalgamated areas - you know, we have a population approaching Tasmania's - it will become the domain of political parties and unions, and I think that will be sad, or we'll have a whole roomful of Mayors that are multimillionaires and we'll have lots of Clive PALMERs running around as Mayors, so to speak, and I don't think the public - nothing against Mr Palmer, but I don't think the public want to see millionaires or political hacks running their councils.

So what I'm saying is, I guess, in essence, there has to be some form of funding in some way, shape or form to run a successful mayoral candidacy campaign in a large region.

CA Another issue is disclosure of donations.

W Yes.

You know from your own participation that the regime of the *Local Government Act* is to require returns to be lodged up to 15 weeks after the election?

W Yes.

CA Given the timing of that lodgement, post election, does that serve the interests of electors in knowing where candidates are being funded from?

It certainly doesn't. There's no way, shape or form it does. And it's a two-stream process, which, in my book, is undemocratic, in that the *Local Government Act* forces disclosure of sitting councillors and Mayors, and yet the *Electoral Act* - of gifts or donations. Whether it be for a political purpose, for a campaign or not, it has to be in the register. So that happens - if you're a councillor, you have to declare it if you get a donation three weeks out. If you're someone campaigning against that councillor, you can be financed by the Japanese Mafia and people won't

find out about that until three months later. And that is very undemocratic, to have one law applied to one candidate and another to another candidate.

CA	You're not the first to say that, Mr SUTHERLAND.
CA	Toute not the first to say that, wit so fill REAND.

W No. It's wrong.

CA Let's change the subject, then.

10 W Yes.

CA You, for the purpose of your 2016 campaign, shared campaign material

with a number of other candidates?

W Yes.

CA There were a number of How to Vote Cards?

W Yes.

20 CA You and other candidates used joint How to Vote Cards - or at least some

candidates; correct?

W Yes.

CA We might have some examples here. I am just interested to know

the extent to which that occurred, Mr SUTHERLAND. There is one here.

It appears to be a joint card with Councillor Julie GREER.

30 W I think I've got them probably all here. I think I've probably got every one

of them here.

CA Is that a joint card that you used for the last election with

Councillor GREER?

W Yes.

CA You think yes?

40 W I'm just looking. It's a little bit greyer than - my version than your version.

CA Okay. Well, the layout-

W That's it.

CA Do you accept the layout?

W Yes, that's it.

50 CA It is not an exact representation, of course.

W No.

CA It's a print. But there was such a card that you shared with her, and it

	W	Yes. I've got a copy of them all here.
	CA	I tender that.
	PO	Exhibit 68.
	CA	You shared another one with Councillor HOUGHTON?
10	W	Yes.
10	CA	Have I pronounced that correctly?
	W	He prefers HOUGHTON, not HOUGHTON.
	CA	Yes. Can I show you this one.
	W	Yes, that's correct.
20	CA	That is one that you shared with Mr HOUGHTON. I tender that.
20	PO	Exhibit 69.
	CA	You shared another card with Councillor GILLAM?
	W	That's correct.
	CA	I tender that card.
20	PO	Exhibit 70.
30	CA	You shared another How to Vote Card with Councillor CHARLTON?
	W	That's correct.
	CA	I think that's Exhibit 37. I am just showing you Exhibit 37. Is that a copy of the How to Vote Card with Mr CHARLTON?
	W	Yes.
40	CA	There was also another with Councillor FLANNERY; correct?
	W	Yes, that's correct.
	CA	I think that is Exhibit 64. That's five. Is that the extent of it?
	W	Sorry, did we count Councillor GREER? Was that the first one?
	CA	Yes, it was.
50	W	Just with Councillor GREER's, I'm not sure, but in the first instance the other day, I thought that that wasn't the original. It was the 2012 one and not the 2016.
	CA	Yes. Did you have one in 2016 with Councillor GREER?
	W	Yes, yes.

	CA	You did?
	W	It's on here, yes.
	CA	The ones that I've shown you so far - and you've got copies yourself?
	W	Yes.
10	CA	They, for the most part, adopt a similar layout in terms of artwork?
	W	Yes.
	CA	How did that come about?
	W	Well, they would have been done by the same graphic artist, at the same print house.
20	CA	At whose instigation?
20	W	Of the artwork?
	CA	Well-
30	W	Well, the councillors that I asked if they would want to do them, some said yes; some said no. There was no binding obligation on them. For instance, Koliana WINCHESTER shared a billboard with us but didn't share a How to Vote Card with us. It's an entirely independent decision. It's a logistical decision, also, particularly for myself, not so much for the councillors.
		And in the 2012 election, we had done the same thing and we - each councillor, I guess, is responsible for their own layout. I mean, Mick's ran with that forever and a day. I guess the fonts and that are very similar, because any graphic artist worth their salt wouldn't have a page with two argumentative fonts, if you know what I mean.
40	CA	From what you said a moment ago, you were the one who initiated the joint How to Vote Card idea?
40	W	I was the one that asked individual councillors whether they would like to share a How to Vote Card, yes.
	CA	So did you ask more than the five, I think, we've seen if they would participate with you in that?
	W	Yes.
50	CA	And some said no?
	W	Yes.
	CA	But five said yes?
	W	Yes.

	CA	And that's how it originated?
	W	Yes.
	CA	There's a cost associated with the printing of How to Vote Cards, of course, isn't there?
	W	Correct.
10	CA	Did you discuss sharing of costs with the councillors concerned that you were sharing with?
	W	Yes, I did. I can't recall - we're going back 18 months ago. I can't recall which ones, but some councillors said, in the first instance, that they'd just go halves, and other councillors, I suggested - well, I suggested to them all that I'd try to make myself available through the campaign to pay for it, but-
20	CA	All of it, you mean?
20	W	Yes, but it must be declared. We can't - I'm not - we weren't going to have anything that wasn't transparent, like, you know, "I'll just do this for you." It has to be declared, and, "I'll see if we can cover the costs." A couple of the councillors at the time said, no, they were happy to pay the costs, and, in the end, they said, "Well, if you're willing to pay the costs, yes, that will be okay."
	CA	So you paid the full cost for at least some of those?
30	W	Yes, providing that it was fully declared.
	CA	By that, do you mean the benefit to them was declared, the cost benefit to them?
	W	Well, I wanted it on their disclosure that I'd paid - Moreton Futures had paid-
	CA	Effectively, a donation from you; it qualifies as a donation?
40	W	Yes, absolutely.
	CA	And that's what you meant, that it should be declared as such?
	W	Absolutely.
	CA	Do you accept that these cards, appearing as a joint image, or I think in Councillor FLANNERY's case back-to-back, involved cross-promotion of the election of the both of you?
50	W	It depends. It depends which way it works and in what area of Moreton Bay Region. To some councillors, it may be detrimental to them, and some councillors - I don't know how you quantify it - it could be advantageous. My vote varies hugely across the region. In the southern areas and in Redcliffe, mid 60s - primary vote, I'm talking about. And the northern area, up to different parts of Caboolture, more like mid 40s. In some places, low 40s. And so if a councillor - what I'm trying to

say, I guess, if a councillor up in the Caboolture area shared their How to

		Vote Card, it might be detrimental to him. But I don't know how you qualify that.
	CA	Okay. We're perhaps at slightly cross-purposes. Just looking at the card, it invites a "Vote 1" for both of you; correct?
	W	Well, they both say "1", yes.
10	CA	And I'm suggesting to you, from that, regardless of the efficiency of that as a How to Vote Card-
	W	But it doesn't-
	CA	Just listen, please.
	W	Yes.
20	CA	I am suggesting to you that that involves, on the face of it, cross-promotion of the two of you supporting each other's election as candidate No. 1?
	W	Well, it doesn't transpose to that as far as the vote goes, because they never marry.
	CA	Okay.
30	W	And in fact, as I said before, it can be detrimental, but it doesn't transpose for that. Examples: in Mike's area, the Albany Creek area, he's the Deputy Mayor and sitting councillor for some time. I outpolled him in his own patch by several per cent. I don't know how that came about.
	CA	Just to take one example, say Mr CHARLTON, on the joint How to Vote Card, as it's represented, can I suggest to you that it involves a representation that you support him, you support his election; conversely, on the face of the How to Vote Card, it involves his supporting your election? Whether that turns out to be effective or not is the question you were answering.
40	w	Yes.
	CA	That wasn't actually what I asked.
	W	Yes, yes, I see what you mean.
	CA	Can I suggest to you it's self-evident, really, that the How to Vote Cards do cross-promote the election prospects of both of you?
50	W	I don't think you can really deny that they cross-promote, but I just don't know how you qualify or quantify it.
	CA	Prior to printing, you had an arrangement with these councillors that this would occur, correct, that you would have joint How to Vote Cards?
	W	Yes.

	CA	Did you hesitate, having made an arrangement with these councillors to do that, that the appearance of the How to Vote Cards as joint cards in each case could give rise to a view that, by arrangement, you had formed a group to support each other's election?
10	W	No, I'd adopt the attitude that most people looking at that by arrangement would see that as the sitting council, not a group. They would see Mick GILLAM and Allan SUTHERLAND. They know Mick GILLAM is their sitting councillor and Allan SUTHERLAND is their Mayor. I wouldn't suggest it's a group as such but more as a council. They're the sitting councillors.
	CA	You had a selected - well, you had a number of councillors whose re-election you favoured; correct? Even by virtue of the fact of the joint How to Vote Card, you favoured their re-election?
20	W	Absolutely. And, conversely, I had candidates that weren't elected asking me to do joint How to Vote Cards with them, and I wouldn't do it, definitely because I thought that that would impact on the impartiality of me as Mayor and that it was open to who was going to be elected in that division and I didn't want to be seen to be influencing the outcome of a division. And Brian BATTERSBY's area springs to mind immediately.
	CA	Okay.
	W	But I don't mind doing it with a sitting councillor, particularly if we've got a respect for each other's ideals.
30	CA	With some of those councillors, you went a step further, didn't you, and wrote letters of endorsement of them?
	W	I did.
	CA	They involved Councillor CHARLTON; correct?
	W	Yes.
	CA	Councillor HOUGHTON?
40	W	Yes.
	CA	And Councillor FLANNERY?
	W	Yes.
	CA	Is that all?
50	W	I think so. I don't think it was Councillor GREER. Did you say Councillor HOUGHTON?
	CA	Yes, I did.
	W	I'm pretty sure that was it.
	CA	Well, this might jog your memory. Could I show you this flyer. Is that a representation of the letter of endorsement that you wrote for Councillor

### HOUGHTON?

	W	Yes.
10	CA	Without going to the text of the others, was it similar in style, endorsing their efforts as a councillor and supporting their re-election?
	W	Yes. If memory serves me, I put a similar letter of endorsement out with Councillor HOUGHTON in the 2012 election also.
10	CA	I tender that letter of endorsement of Councillor HOUGHTON.
	PO	Exhibit 71.
	CA	The letters that you wrote in due course were the subject of mail-outs to electors, were they not?
	W	Yes.
20	CA	In all three cases?
	W	Yes.
	CA	And the letter of endorsement came to be printed in a fashion like that?
	W	Yes.
	CA	Is that the form in which the letter was mailed out, do you remember?
30	W	Well, it went with a delivery person.
	CA	Did it?
	W	It didn't go-
	CA	Not by mail, as such?
40	W	Oh, no, no, it didn't go - it was like, Iris Delivery, or someone like that, yes.
40	CA	But in any event, distributed to electors?
	Ŵ	Oh, absolutely, yes.
	CA	In a form like that, as a flyer?
50	W	As a flyer. It wasn't an "Australia Post Paid" thing. It was the cheaper version, the delivery version, where it ends up with your Woolworths and BCF and whatever in your mailbox.
	CA	Did you assume the cost of the delivery of the flyers in each of those three cases?
	W	Yes. Once again, on the same basis, that it would be declared as a gift, a third party gift, or whatever way we had to declare it.

	CA	Did you offer to those candidates to assume that cost?
	W	Yes.
	CA	And they were agreeable, subject to declaration?
	W	Yes, yes.
10	CA	You have already mentioned billboards, I think. There were shared billboards with a number of candidates, also?
	W	Yes. The same applied, providing that we worked out the best - to the best way we could to declare it.
	CA	Is it right to say, again, that those billboards appeared as joint billboards at your suggestion to the other candidates?
	W	Yes, I rang them up individually in most instances, as I recall, yes. I remember a couple of the discussions.
20	CA	Billboards are a bit like the How to Vote Cards, aren't they? They involve a representation that you support each other for the purpose of election?
30	W	Well, I wouldn't suggest that it was a - I would suggest it could be taken as support, yes, but it certainly - if you're on the same billboard together, it's support. But it's not - I wouldn't suggest it's a group as such. There was never anything where we all appeared, the sitting councillors, together or anything like that. It was on an individual basis, and it was more support depending on, I guess, I thought the situation at the time. The decision was never made together of a How to Vote Card and a billboard and a letter. It was rolling through the course of the campaign. If memory serves me - and I'll stand corrected - I think all of them were my decisions and it was based on concerns I had as the campaign rolled out.
40	CA	Arising from all of that, I'll ask you again, from the How to Vote Cards, the shared billboards, letters of endorsement mailed out under your name, et cetera, all of which was by arrangement with the candidate concerned, did that give you pause as to whether you might either be seen to be or in fact be a group for the purpose of the <i>Local Government Electoral Act</i> ?
	W	No. I think it's fair to say there was much discussion amongst councillors whether - I think it was the 2012 election, too, whether we nominate as a group. But there's fierce independence in our council, and it's probably the strength of the Moreton Bay Council and why they've survived so long relatively intact against the flow of councils in Queensland.
50		I don't think anybody wants to be beholden or reliant on each other. I had an example in there today of the council meeting on Tuesday, where there was - what would you call it? - a very contentious issue, which managed to go to the editorial level of the newspaper. There was an editorial written on it, plus a story. And the vote, by memory, was 8/5, both new and old councillors seemingly across the board, depending on their belief.
	CA	All right.

	W	I don't think anybody in our council would ever consider a bonding to the degree that we would think there was a group. In fact, we had a list of things we went through when we looked at the legislation, and we didn't think we complied with any of them.
	CA	So far as voting is concerned, at least, I think the effect of what you are saying is that, in your view, there are no groups for the purpose of voting on council business?
10	W	That's correct.
	CA	We have mentioned disclosure previously. You know that personal disclosure returns of gifts have to be made to the Electoral Commission after the election, and you did so after the 2016 election; correct?
	W	Correct.
20	CA	Your personal disclosure return, which we'll go to a bit later, shows large donations from Moreton Futures Trust; correct?
20	W	Correct.
	CA	Was 2016 the first election campaign in which you'd received donations from Moreton Futures Trust?
	W	No, the second. 2012.
30	CA	Okay. What about 2008, had you received donations for a campaign from - I think Moreton Futures Trust perhaps didn't exist at that stage, but from any predecessor?
	W	No. I believe they actually campaigned against me.
	CA	There was an entity - you might be able to give us the correct name - it has been referred to variously, I think, as Pine Rivers Futures Trust and Friends of Pine Rivers?
40	W	Yes, I thought it was Pine Rivers Futures Trust, but I was since told it was Friends of Pine Rivers, or something like that, yes.
40	CA	What do you know of it? You said, I think, that there had been a campaign against you in 2008?
	W	Well, there was a campaign against everybody because we were amalgamating-
	CA	Yes.
50	W	I didn't know anything about it in 2008. I knew that there was a large hostile bloc in that area that didn't want me as their Mayor. In fact, I can remember How to Vote Cards, their suggestion for Mayor was "Put SUTHERLAND last". It was a hostile campaign, to say the least. But it was only after the 2008 election, in newspaper articles, I think, they were on about this fund or trust or whatever it was.
	CA	One of your opposition, at least, was Bryan GALVIN?

- Another problem is that when that situation arises for you, and you feel the need to exclude yourself, you, as the Mayor, are not then participating in council business?
- W
- Yes, and you don't have to-

CA 50 It's symptomatic of the problem with the donation system, is it not?

W

Absolutely. And you don't have to leave depending on the level of involvement. You can declare that you've got an interest, but you don't think it's an issue, and you can stay if you like. I don't think that should be up to the decision of the councillor. I've had instances, as Mayor, over the time, when I've had heated debate and asked people to leave the room and they've turned around and told me that it's their decision, not mine.

I think it should be a decision of the council, and the council can be the one that can decide whether you should walk from the room or not, not the individual.

CA In your experience, can individuals be relied on?

W In my experience, you usually find out after the fact.

CA Are people prepared to run the risk that that might happen? Is that within your experience?

Over many, many years I have seen it happen from time to time, but you find out usually after the fact. I know in the first couple of years of amalgamation in Redcliffe, it was easy. We were a small community. I knew who was who in the zoo. After the amalgamation, in the first couple of years you had to have eyes in the back of your head, and you'd find out two years later that a development was approved and, "Didn't you know that they were so and so?" "No." It was a little bit problematic in the beginning. It's still-

Is there a bigger category of donors presenting this difficulty? Is it developers or is it wider than that?

I know it's contrary to public belief, I get it, and I can understand the extreme suspicion of the public when it comes to donations, particularly developers. I do think, in a lot of instances, it has the reverse effect.

My honest opinion - for instance, you used the name David TRASK. I think as far as he's - he's one of the biggest developers in the region, has been for a long, long time, and was the biggest in Redcliffe, too. I would suspect that his involvement in my campaigns - and I think if he was in the room, he would most certainly say it - as far as his development applications go is to his detriment, because I think the organisation, be it the planners, go out of their way to make sure that there's no issues with any of his applications. So he probably gets a triple look at his issues.

The reason I believe - and I've talked to Paul and other Mayors about it on many occasions - that particularly developers donate - and as I said before, I appreciate that the public don't think this, and I get it, I understand why - donate to election campaigns is because if you haven't got a strong council and if you haven't got a strong Mayor, areas do wilt and wither.

And when I joined Redcliffe Council in 1994, Redcliffe was called "Deadcliffe" and a couple of other pretty horrible names, and it took a lot to turn that place around. I guess the development community in Redcliffe was more or less going broke because there was no development.

Moreton Bay Region in 2015 was the fastest-growing economy in Queensland, and I would suggest to anybody that part of that was the drive of the council. We went out of our way to attract people like Costco and IKEA and negotiate a successful rail line, and we're working on a university now, and that's our job as a council, to move economic development forward. The flip side of that is that it makes it a pretty

10 W I'm not in ignorance now. I haven't been in ignorance for some time.

CA But you told us you didn't see the need, at least, to go back to the return and look at it?

It hadn't been such an issue as it has been since this investigation started and it really wasn't a high priority. It was something that I didn't - I wasn't worried about. And the reason I wasn't worried about it was because still, as we sit here at the moment, I believe that it was a big campaign, and in every campaign you do your best effort to try to comply with the rules that we've got.

Are the rules that we've got good? No, they're not, but they're the rules that we've got. I have spoken to Greg HALLAM from the LGAQ about it. I've spoken to our councillor lawyer about it. And the fact is - and it's an issue and I concede it - the issue is that you don't have to even walk if it goes through a thingo. That's up to you. That's a personal decision for yourself or myself to make if you're a councillor. As I would see it, it would very much depend on me whether there was a motive issue, what the thing was.

Since speaking, I've actually asked our planners on a couple of issues here, and one of them was Ushers. Ushers have a development in our PDA area, and I asked them what my concerns were, in that I know they donated to this, it's on there, but I was told that Usher's DAs are all in place for that area.

So, yes, you're mad if you don't have a look. And, as I said, after the election, I was happy to get through the election and I was not - it just wasn't in my head space to go charging around looking at things.

Would you accept that anyone who chose to make the comparison between this third party return of Moreton Futures Trust and your personal declaration of having received money from Moreton Futures Trust would reveal that the use of an intermediary, being the trust, does not conceal that you benefited heavily from developer donations to your campaign?

It does, because they would have to, and they do - most people that are interested to look at things like that would then look up Moreton Futures' declaration, too. So if you're going to be interested enough to look at that - they're all online. It's not hard. You look at one. Who is Moreton Futures Trust? Then look up Moreton Futures Trust and see what they are. That's what's happening in the community as we speak.

Yes. What I am really suggesting is that the use of a trust is really ineffective in distancing you from the fact that property developers were

heavily donating to your campaign because it's evident from comparing your personal return with the Moreton Futures Trust return?

W And I would suggest that it wouldn't matter whether they donated to myself personally or this, as a rule, depending on the issue, I would probably walk.

Mr SUTHERLAND, why would you walk if you don't know who the donor is?

W Well, I do now.

PO You do now, but-

Look, I was happy not to know. It's hard to have a conflict when you don't know who the donor is. But, you know, when we talked about this, when the investigation started, I don't know if it was before or after, I definitely made myself aware of everybody. I had a rough idea who was in there, because David would say, "I got some money off this fellow. I got some money off that." I knew Newcombe Holdings had put money in there. I didn't know Open Corp Project Management. And I know exactly what you're saying, and I concede that.

I actually rang up Greg HALLAM and said, "What's the rules and regulations on the trust?", and the advice I got very strongly was you don't necessarily have to walk, it's up to you, when it comes to things like that. But I concede what you say. I concede it. I understand it. That's why I don't like the whole system. I mean, no-one wants to be in this place, believe me.

It's really in the perception of the electors, isn't it? They're the ones who count, aren't they?

Of course it is. I don't know any Mayor that wants to be in this position, to go out every election, rattling a can, trying to get money. And that's what I'm saying: my greatest fear is, at the end of the day it will be that hard for individuals like myself, I believe, true independents, to be able to run as Mayor in places like the Gold Coast, Moreton, Sunshine Coast - the large Brisbane, of course, is politically divided, but it will be almost impossible unless there is some form of funding or whatever, because it would be so easy, when you see in my backyard, for instance - and I have no problem with it; it's their business, but if a union puts in \$32,000 to one councillor's campaign, what would they put into a mayoral campaign? They might put \$300,000 or \$400,000 in if they knew they could get a Mayor across the line.

I don't want to see that happen. I don't think it is in the public's interest. The point is, somehow someone has to fund the campaign. I've said I think the system is broken, and I think what we've got is broken, and some of it is because of those disclosure issues.

Tell me this: now that you're aware of the contents of this list of donors, does that present you, or do you think that presents you, with any conflict dilemma concerning any applications that those donors might make to the council and your participation in that?
