- W Being party endorsed?

- 10 CA No. I'm asking, really, generally-
 - W Yes.
 - CA -whether you have a view about whether councillors should be party aligned as being endorsed by a party in the same fashion as state and federal, or not?
- W I have a view that council, local government representatives should be independent because they have a specific passion for the area that they 20 represent, and my view is that it's that passion that makes a good representative, not the membership of any political party.
 - CA Some candidates and councillors are, however, members of political parties.
 - W Yes.
 - CA Does that impact on their independence that you regard as desirable?
- 30 W I don't believe so.
 - CA You found out, I think, about five weeks before the 2016 election that you were not going to be opposed?
 - W Something like that.
 - CA One consequence is that you didn't have to print How to Vote Cards?
 - W No.
- 40
 - CA Or man booths?
 - W Right.
 - CA That must have been a relief, I assume?
 - W A big relief.
- CA But you had, however, undertaken some fundraising in the course of the 2012 to 2016 term; correct?
 - W Yes.
 - CA I just want to ask you a bit about that.

- CA How did you undertake fundraising for the purpose of your anticipated 2016 campaign?
- W I had two fundraising events, which were race days, whereby a database of potential attendees was formed and invitations issued.
- CA In what years were they held?
- 10 W 2014 and 2015.
 - CA Were they the only two fundraising functions you conducted during that term?
 - W Yes.
 - CA You mentioned a database of potential invitees.
- W Mmm-hmm. 20
 - CA How was such a list devised or selected?
 - W Initially, probably for the 2008 campaign, my son assisted with the beginnings of the database, and, as time went on, I used email addresses from contacts that I had made over the term of my representation.
 - CA Were the invitees, then, persons with whom you had had some contact or were you casting the net wider?
 - W I cast the net wider.
 - CA I'm really interested to know how you selected persons who might be on your invitation list. Were there any criteria?
 - W No.

- CA How did you go about it, then? You just had the phonebook, or what?
- 40 W When my son started, with his staff, the initial list, it was simply based on businesses in the area of my representation. So that was the initial construction, and a lot of businesses that I had no knowledge of or contact with formed part of that initial database, which grew over the years, obviously, through my representation.
 - CA So the focus, initially at least, was on businesses in your division?
 - W Yes.
- 50 CA You say that that grew to include what kinds of people beyond the business community?
 - W Well, it included all types of businesses legal firms, firms that I had met through community meetings and business breakfasts, obviously the development industry. Everyone that I felt that I could seek support from to continue in my role.

- CA For each of these race days, having established a database such as you have described, how did you effect the invitation?
- W An invitation was designed and prepared, a date claimer was sent out notifying the proposed date, and thereafter an invitation issued, all by email.
- CA Did the invitation make it plain in each case, 2014 and 2015, that the function was for fundraising purposes for you?
 - W Yes.
 - CA Do you recall what it said to indicate that?
 - W I'm pretty sure it had the fundraising details on it, that it was an invitation to a race day, and it provided my campaign account details and the banking details for direct deposits into that account.
- 20 CA So is it fair to say that no-one could have any misunderstanding that the function was for campaign fundraising for you?
 - W Absolutely. Very clear.
 - CA When people decide to accept, presumably they need to make some payment?
 - W Yes.
- 30 CA How was that arranged, for receipt of money?
 - W There was a dedicated bank account for my campaign and those details were on the invitation. So I monitored the receipt of funds into that account.
 - CA Where were the race days held, by the way?
 - W At the Gold Coast Turf Club.
- 40 CA So all of the money by way of subscriptions for the day came into your dedicated bank account?
 - W It did.
 - CA And on the other side of the coin, there were expenses to be met for the conduct of these race days?
 - W Yes.
- 50 CA Did they come out of the same account?
 - W Yes.
 - CA So for all intents and purposes, you kept a dedicated bank account, as required?

- CA I see. That's the typed list or spreadsheet that you're referring to?
- W Oh, I'm sorry, yes. I don't have anything-
- CA You're making the point-
- W I'm sorry, I see it here on the front page. Yes.
- 10 CA You were making the point, I think, that the proceeds from the race day, as per the schedule which is included, was \$166,000?
 - W No. You were correct. The \$173,000 is the total amount, but that includes amounts under \$200-
 - CA Understood.
 - W -in addition to these that are identified as over.
- 20 CA You have shown 110 donors altogether?
 - W Yes.
 - CA But as you point out, they may include persons who donated under \$200?
 - W Yes, they do.
- CA Nonetheless, on the schedule of donors over \$200, there is still quite a large number of entries; do you agree?
 - W Agree.
 - CA Tell me this: the amounts that are shown there as against each of the persons identified, are all those amounts referrable to the cost of tickets or are there donations in addition to the cost of tickets?
- W There are a couple of donations in addition to tickets. This is every amount over \$200 received during the declaration period.
- CA What proportion of these would be we don't have to have exact figures, but I just want to get a feel for what proportion would represent those who had purchased tickets?
 - W Ninety-eight per cent.
 - CA Okay. A very large proportion.
- W A very large proportion. 50
- CA Even as we look down the list of donors, there are some names that are obviously referrable to property interests or development interests; correct?
 - W Correct.

- CA Without perhaps going through the whole thing, you may be aware of an ABC News article in July 2016 that referred to your disclosure return and suggested that of the amount shown, \$166,000 or so, about \$120,000 was referrable to the property industry and about-
- W I'm not aware of that media, but I would suggest that's probably correct.
- CA You say that sounds right?
- 10 W Possibly.
 - CA The article goes on to say that \$80,000 of the money that's set out in the schedule comes from property developers.
 - W Right.
 - CA Does that sound correct?
- W I honestly haven't gone into that detail, but significantly there were a lot 20 of property interests at my race day.
 - CA At the least, some tens of thousands of dollars?
 - W Yes.
 - CA In that category?
 - W Yes.
- 30 CA Perhaps up to \$80,000?
 - W Yes.
 - CA And as we've noticed already, there are a lot of names, of amounts ranging between \$390 or so up to \$5,000 or more?
 - W Yes.
- CA Can I ask you this, then: having regard to the extent of financial support from property developers and other property interests, and given the wide number of donors, how do you go about managing actual or perceived conflicts between doing council business and the fact that property interests and property developers have substantially assisted your campaign?
 - W I've maintained a list of donors and I carefully scrutinise the agendas which we get. We have two meeting rounds each - a meeting round each week and a full council thereafter, and I scrutinise the agendas to be sure that I identify any of the consultants to the industry or development industry that have provided me with support.
 - CA Do you use a list such as this?
 - W Yes.

- W I believe I comply in every way by declaring the perception, the possible perception, of a conflict of interest but by doing the right thing if I'm in the room.
- CA Well, you've explained your position clearly.
- W Yes.
- 10 CA Thank you. But I am just wondering whether you accept that that leaves people to wonder about the appearance of impartiality, notwithstanding your declarations of integrity?
 - W It's possible.
 - CA To take an example of your approach, you may be aware of an article last year, in August, in the Gold Coast Bulletin about a development at Pimpama?
- 20 W I remember that well.
 - CA The author of the article questioned your voting on a development application involving one of your donors who had attended your race day; correct?
 - W Yes.
 - CA And contributed \$500 to your campaign fund-
- 30 W Yes.
 - CA -by that means?
 - W Yes.
 - CA You declared a conflict of interest on that occasion, I think, concerning that development application?
 - W I did.

- CA According to the report, you said that you were comfortable voting, guided as you were by recommendations made by council officers?
 - I was, but I made some changes that I wasn't happy with that I felt would be a better legacy for that area, and that was why the street frontages and - that's one thing. And I believe there was another one, I can't remember what it was, but the applicant had wanted 11-metre frontages, and I wanted 12 because I feel that it provides a better outcome for the community, so I had that change implemented.
- CA Would you accept that even the fact that an article of that kind is written highlighting a conflict of interest, which you declared-
 - W Yes.
 - CA -followed by a vote by you in favour of a development, illustrates

the tension between the appearance of impartiality when donations are made to your campaign fund by developers?

- W Possibly, yes.
- CA Can I just ask you if you have a view about whether there is a better model for funding of local government campaigns than to receive large sums from developers and then simply make the declaration of interest and continue to vote, as you, in the main, do?
- W I have felt that I've complied with the current regulations. If the regulations were differently constructed, it wouldn't concern me.
 - CA You recall being asked questions by Commission officers when they had an interview with you.
 - W Yes.

- CA I think you may have said on that occasion that making a donation can open the window for an appointment with you?
 - W I think I recall suggesting that I would work a little longer hours in order to meet with someone if necessary, but I'm very open to appointments from anyone, no matter whether they've made a contribution to my campaign or not.
 - CA Knowing, as you do, the list of your donors-
- W Yes. 30
 - CA because, from the sound of it, you consult it regularly is that right? Do you consult your list of donors regularly?
 - W No.
 - CA Only when you get an agenda for council business?
- W I never seek consultation with them other than through the council process. They sometimes approach me for an appointment if they have a specific issue that they seek assistance on in the consideration of their development application. That's quite a common occurrence.
 - CA Does making a donation supporting you on your race days improve a donor's prospects of access to you?
 - W No, but, in all honesty, I would just make my day either start earlier or finish later to try and make myself available if it was something that was - that I could assist them with. On occasions, they might make contact with me, and if I knew the substance of the reason for the meeting, I might decline it.
 - CA Do you feel, having received money by way of support at your fundraising functions, that when a donor seeks to consult you about something, you have some obligation to make time available to the donor?

- W I don't feel an obligation specifically in that regard. I feel an obligation in terms of being a local government representative. I don't always agree with what is put to me. I'm totally impartial in terms of my representation, other than getting the best outcome possible.
- CA That's the evidence, Commissioner.
- PO Mr RICE, did you want to tender that disclosure return?
- 10 CA Yes. I hadn't done so. I tender that disclosure return.
 - PO That's Exhibit 78. And did you wish to tender that more recent newspaper article you asked questions about, the August one?
 - CA No. I was really using it as an example to explore some of the issues, Commissioner. I hadn't proposed to tender it.
 - PO That's all right. Thank you.
- 20 Mr MCMILLAN, do you have any questions?
 - LR I have no questions, thank you, Commissioner.
 - PO Thank you, Ms GATES. You are excused.
 - W Thank you, Mr Chairman.
 - PO Mr RICE, I notice the time. Do you wish to have the morning break slightly early, before you call your next witness?
 - CA That might be convenient, Commissioner.
 - PO We will adjourn now and resume at 11.30.
