Threats to Staff Safety - General Manager's Response

In addition to the criminal and legislative processes for offences and breaches of discipline, the following General Manager's responses for a prisoner's actions that impacts on or threatens staff safety are as follows:

Illicit Drugs - General Manager's Response

In addition to the criminal and legislative processes for offences and breaches of discipline, the following General Manager's responses for a prisoner's involvement in illicit drugs are as follows:

Incident Type	General Manager's Response	Duration
<ul style="list-style-type: none">• Illicit Drugs – Supply	<ul style="list-style-type: none">• Sanctions*	6 Months
<ul style="list-style-type: none">• Illicit Drugs – Possession	<ul style="list-style-type: none">• Sanctions*	3 Months
<ul style="list-style-type: none">• Telephone Misuse – Intelligence indicating the supply of and/or payment for illicit drugs.	<ul style="list-style-type: none">• Removal and prohibition of telephone number	Indefinitely

* Sanctions = non-contact visits, 7 x personal phone calls per week, not eligible for residential for 3 months post completion.

Threats to Prisoner's Safety - General Manager's Response

In addition to the criminal and legislative processes for offences and breaches of discipline, the following General Manager's responses for a prisoner's actions as a perpetrator that impacts on or threatens other prisoner's safety are as follows:

<ul style="list-style-type: none">• Assault (Sexual) – Prisoner on Prisoner• Assaults & Threats (Frequent & Repeated) – Prisoner on Prisoner• Bullying and Stand-overs (Frequent & Repeated) – Prisoner on Prisoner• CMG and/or Prison Gang Recruitment or Activity considered a threat to the Good Order and Security	<ul style="list-style-type: none">• Intensive Management Plan	Subject to the General Manager through the IMP Panel.
<ul style="list-style-type: none">• Telephone Misuse – Intelligence indicating the recruitment and/or activity related to CMG and/or Prison Gangs.	<ul style="list-style-type: none">• Removal and prohibition of telephone number	Indefinitely

Note: All General Manager's Responses - the application of responses, discretion still remains with the General Manager to take into account any significant mitigating circumstances such as mental health or any other diverse circumstances that may have existed at the time of the incident or impact on the ongoing management of the prisoner.
