Thanks for your faxes – they make very interesting reading. Couple of comments:

- The 'Achieving/Working for You' Labor flyer is pretty much the same across all electorates for all Labor candidates, however I don't feel there is a need to change your strategy at this point. It's still a good strong, relevant line.
- Local Government is Politics and as such, difficult to avoid. The theme you need to emphasise is "Let's keep PARTY politics out of Local Government!"
- "I live in the electorate" could also be stated as "An independent local boy for local government – let's keep Party politics out!" or similar. These are the type of statements that you can regularly include in any media statements and public meetings.
- I'm not too sure about your third comment. Probably need to discuss that one further.
- Rod Wellfords note is positive. Give some thought to his former portfolio – there may be an angle on foreshore environmental issues that you are promoting that he can endorse or support. Won't do any harm with the Green Vote either. Alternatively law & order issues – what is there in Division 3 that is an issue and what solution do you propose that the Attorney General could support? All demonstrates your ability to work with State.
- Of course as an Independent, you need to balance that Labor support with support from the conservative side – and something from Rob Borbidge as well would be useful if we are to present all these endorsements or comments of support as a one page ad demonstrating your contacts & that you can work with all people across the political spectrum.

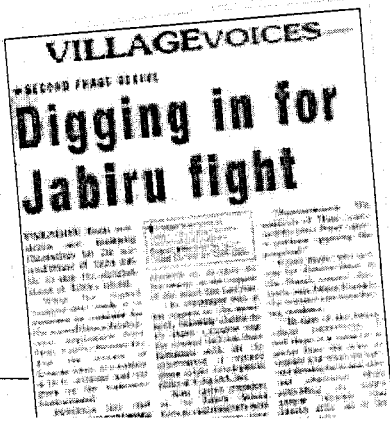


**Extra storage still needed**

**Respect for the environment**

At the first informal councillors dinner some very healthy debate took place, several strong nominations for Chairs were received & voted on democratically. We all should have stood by these decisions to move forward – it is what the people of the Coast would have expected. Instead, what was said saw Council's first meeting break from protocol by a few disgruntled councillors. I'm a team player working with what I believe could be a cohesive Council and it's time all Councillors got the message & got on with their jobs of representing the people.

This is my first time running for Council and we ran a long, hard, good campaign with a lifetime of voluntary community work behind me, I felt I was the best person for the job, & obviously by the voting majority also.
