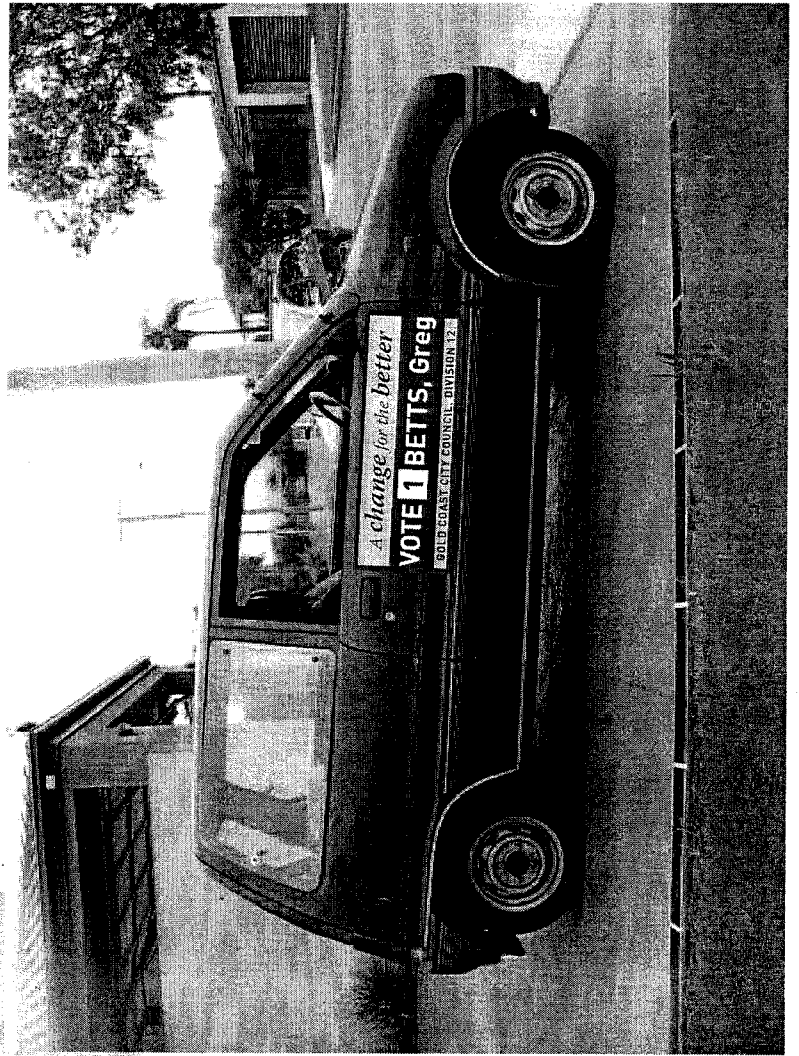

Hi Sue,

Got through to Max on his mobile this morning after I spoke to you. Asked him about the postal vote info, he said they were getting it put together and it would be available electronically. Once it is done he said I could get a copy.

As an aside to the election that is gone - there is another coming! Today I read in the Sun Newspaper an ad from Margaret May. It was titled McPherson News and there was a bit of a surprise. There is going to be a redistribution in the electorate. They are going to create a new electorate called BONNER. It will run between Broadbeach and Christine Avenue. Why don't you consider running for Federal. As a new seat there is nobody to try to knock off, and you already have the profile to win it. Anyway, just a thought - you may have had enough of politics for a while!

Max, how can I get the postal voter list from you? Tim said last week that it would become a public document after the election was over and it was ok for me to get it.

Anyway, hope you get to take a well deserved break with your family for a while.

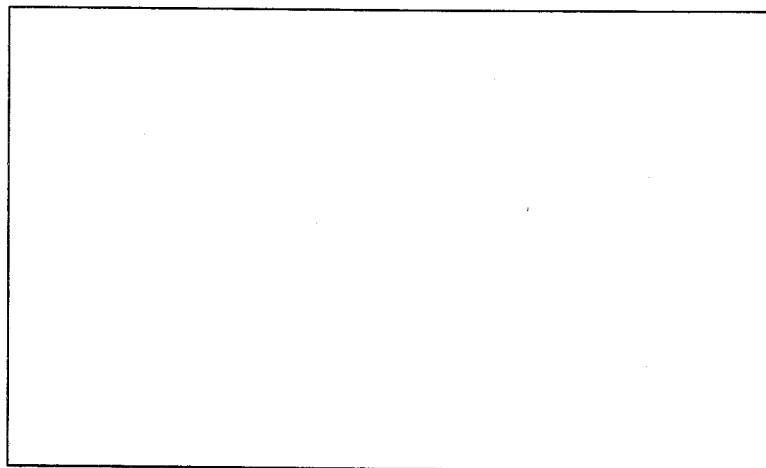

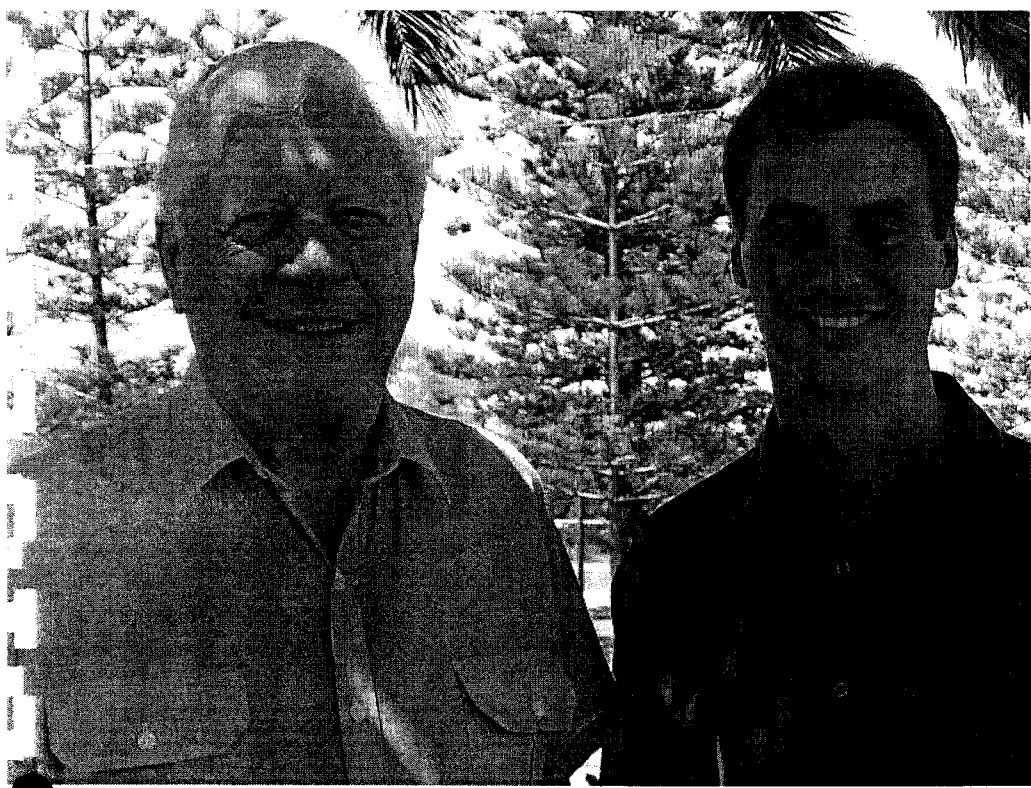

FROM ONE TREK TO ANOTHER

Trekking is nothing new to Greg Betts, Candidate for Division 12 in the Gold Coast City Council election on the 27th of March.

Last September Greg completed a challenging trek across New Guinea's Kokoda Track to raise funds for the Broadbeach Police Citizens Youth Club. Since then he set his mind to face the challenging task of doorknocking one of the most populous Divisions in the Council Precinct.

"It's a big but necessary task. Residents can meet me and discuss any issues of concern," Greg said.

"I'm finding that the biggest issue that concerns the majority of residents in my Division is the raising of the Hinze Dam. They say they have heard enough talk on this issue and want Council to get on with it. Many are also surprised to hear that the current plan to raise the wall four metres for flood mitigation will not help with water storage. The extra space is to be kept dry in case of extreme weather events.... a kind of insurance policy".

Greg supports the original plan to raise the dam wall by sixteen metres, to the full stage three level. "The dam was planned to go to three stages so it could supply the growing needs of an increasing population. That plan has been hijacked. The Council needs to get back on track and follow through with planning decisions that are made."

Greg's trek through Division 12 has taken him to a cross section of streets in the area. He has tried to spread the door knocking out into different areas so he can get to hear what he calls the "neighbourhood issues". He says, "By election day, I think I will have covered most of the Division. If you see me out there, give me a wave – I would appreciate every little bit of encouragement".

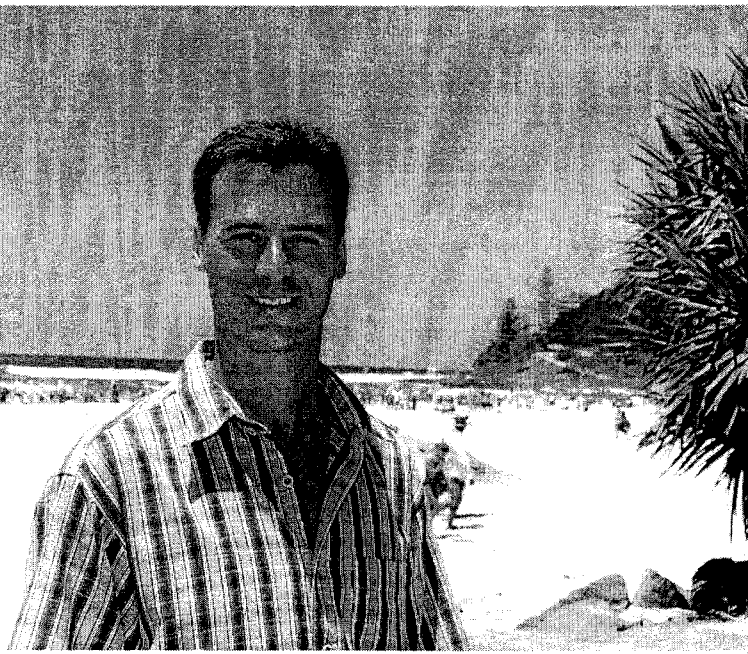
