**A Personal Note to the Senior Citizens of Southport
from Roxanne Scott GC City Council Candidate for Division 6.**

As someone with a mother in her seventies, I am very aware of the many issues faced by our elder citizens.

In Heath Street Southport for example, in front of the ARBI home for the aged, residents do not have a safe footpath – just a narrow bitumen strip sectioned off with concrete blocks. The rough surface makes walking both **difficult and dangerous**. (pic - caption Roxanne & her Mum examine the dangerous Heath St footpath)

The Gold Coast Bulletin reported on March 1 that **millions of dollars in compensation** was being paid by the Gold Coast City Council to people who trip and fall on footpaths.

I am **astounded** at the poor standard of curbing and footpaths in general. Given the extremely high volume of foot-traffic in the Southport CBD, including aged care people with walkers, I am concerned about both the danger of injury to the elderly and the potential for litigation, that will be paid for with ratepayers' money.

Southport, the business and medical heart of the Gold Coast, should shine in terms of presentation to the public. Instead, many areas look like they belong in a developing country, not a thriving city of 450,000 people.

Lest We Forget

I am also **astonished** that Anzac Park near Southport Swimming Pool on the Broadwater has been forgotten by your current councillor.

The blackened, aged garden beds of Anzac Park with not a plant in sight, are a pitiful tribute to our fallen soldiers. These gardens should be the pride of Southport at the height of summer. A colourful reminder of our past and a feature of our Southport foreshore.

As it stands, it appears that a bit of modern landscaping and some colourful plants are just too much of a price for our fallen soldiers.
