Further to your fax request of 7 October 2005, please find attached a detailed summary of all invoices, all payments received, from whom and relevant date received, from and to all individual candidates or groups in any way associated with the 2004 GCCC local body elections for whom we (Quadrant) provided marketing services.

Flease note that all invoices to the Division 9 Campaign of Cr Ted Shepherd were paid by Cr Ted Shepherd. Cr Shepherd's Division 9 Campaign was not in any way the recipient of funding from the Lionel Barden Trust Fund. Campaign activity for Division 9 was managed independently by a separate Campaign Committee of which I was a member in a private & personal capacity. No Division 9 Campaign Committee meetings took place at Quadrant. Quadrant contributed only part of the promotional services and supply of printed material for this campaign.

Flease also note that all invoices to candidates featured, represent the nett cost of all work specified. Quadrant's income took the form of three individual monthly consultancy fee invoices of \$10,000 + GST

All invoices received were apportioned over outstanding candidate client account balances at Quadrant's discretion. At no stage were we directed as to whose account monies were to be credited. At no stage were we asked to who these monies were to be allocated.

Rease note that in all instances Quadrant were paid directly for some campaign expenses by individual candidates Pforr, Scott and Betts. Not all monies received by Quadrant for Grant Pforr's dampaign for example were from the LBTF. These amounts are listed separately on the attached summary.

the time of the elections on March 27 2004, an outstanding balance of costs existed—costs which were subsequently recovered over a period of several months as detailed.
