#### **Gold Coast City Council Inquiry**

#### Personal details

- 1. I am a director of Mandra Pty Ltd trading as Quadrant ("Quadrant") which is an advertising agency. My curriculum vitae is Attachment 1.
- 2. I have provided several statements to the Crime and Misconduct Commission ("CMC") since the beginning of this investigation. I supplied the original statement on 19 August 2005 and supplied supplementary statements on 28 September and 11 October 2005. In addition, I supplied a financial summary to Lincoln Hansen of the CMC on 10 October 2005.
- 3. I have been advised that there are some aspects of Quadrant's involvement in the matters which are the subject of this Inquiry which I have not yet explained in my earlier statements. I wish to supplement these materials with some further explanation about some specific matters:
  - 3.1. The circumstances of Quadrant's retainer.
  - 3.2. The circumstances surrounding a meeting held at the offices of Quadrant on 16 December 2003.
  - 3.3. The involvement of Quadrant in relation to the election campaign of specific council aspirants in the 2004 elections.

#### Circumstances of Quadrant's Retainer

- 5. I was first approached about Quadrant providing advertising and marketing services relating to the March 2004 Gold Coast City Council election by Tony Scott, my business partner and CEO of Quadrant, on 2 December 2003. I was told by Tony that he had been approached by one of Quadrant's long term clients, Brian Ray (now deceased) of The Ray Group, raising the opportunity for Quadrant to undertake an advertising campaign during the upcoming Gold Coast City Council elections. Tony suggested that it was a good opportunity for us given my past experience in working on an election campaign in New Zealand and in working in my private capacity on the campaign of Gold Coast Councillor Ted Shepherd.
- 6. In my handwritten notes of 2 December 2003 in my daybook I have recorded my conversation with Tony Scott: <u>Attachment 2</u>. From my recollection, and by reference to my notes, I recall:-
  - 6.1. That Tony mentioned to me that Gold Coast City Councillors/candidates were potential new clients to Quadrant.
  - 6.2. We discussed the commercial process of how Quadrant could be paid within the accountability framework governing council elections.
  - 6.3. We agreed that it would be more transparent if Quadrant charged a fixed fee of \$10,000.00 per month for the three month period before the election was scheduled to take place.
- 7. A budget of some \$300,000.00 was envisaged.

# Circumstances surrounding a meeting held at the offices of Quadrant on 16 December 2003.

#### Meeting of 3 December 2003

8. Tony Scott and I then had a meeting with Brian Ray at 11.30am on Wednesday 3 December 2003, in Mr Ray's office which is in the same building as our offices. My diary for that date has a notation "11.30. TS/Brian Ray" which was a reference to the meeting with Tony Scott and Mr Ray: <a href="https://example.com/Attachment-3">Attachment 3</a>. I made some brief notes of this

meeting: <u>Attachment 4</u>. These notes record that "Robbins & Power" were noted as the prospective clients. This was reference to Mrs Sue Robbins (also now deceased) and Mr David Power both of whom I then knew to be existing councillors of the Gold Coast City Council. However I had no prior association with either of these councillors.

- 9. I cannot now recall the circumstances surrounding my notation "Exec. Dir. CM". It may have been suggested, in this meeting, that I be appointed Executive Director of the new clients' project or campaign, however, for the reasons that follow that course never eventuated. The next entry in my notes: "Function CM to follow up with donors and confirm funds..." also appears to suggest that I might follow up with donors and confirm funds for the campaign. Again, this did not eventuate although I did subsequently meet with Mr Ray's lawyer Tony Hickey about the establishment of a trust fund to administer donations; however the establishment of a trust fund had not yet been mentioned at this time (3 December 2003).
- 10. I was approaching Quadrant's involvement in this matter in a commercial manner albeit it was an unusual and interesting brief, referred by a valued and long term client. I was speculating a little as to the scope of the work that might be performed but there still had not been any actual contact with the prospective clients. Discussions at this early stage were geared towards preparing the right pitch for the clients. Obviously, the more that I could deliver meant the scope of our work would increase as would our entitlement for a fee. Given my previous work on similar issues and based on early perceptions as expressed to me by Messrs Scott and Ray, I initially began to conceptualise a campaign for a group of like minded individuals taking a common sense approach to public office and set about endeavouring to understand the issues facing candidates in the council elections (hence my listing of issues like "Qld. Water, Traffic, Airport, Tugun By Pass" in Attachment 4 which were all issues then current in the local media on the Gold Coast).
- 11. At the meeting of 3 December 2003, we agreed to meet again on 10 December 2003.

#### Meeting of 10 December 2003

12. My diary for Wednesday 10 December 2003 shows an entry for a 9.30am meeting with "Brian Ray + 2": Attachment 5. This meeting took place in Mr Ray's office and was attended by the late Councillor Sue Robbins, Councillor David Power, Brian Ray and myself. I had no involvement in the invitation of the two councillors.

- 13. I made handwritten notes in my notebook headed: "Commonsense Candidate Resource" at this meeting: Attachment 6. At that stage, I understood the objective to be that of a coordinated, campaign namely to have like minded, commonsense people elected to council who could work with other councillors, who were capable of making decisions and conducting themselves in a professional manner thereby projecting a positive image for the city as civic leaders.
- 14. Although not recorded in my handwritten notes of the December 10 meeting, the issues discussed at that meeting were more extensive and are reflected in my e-mail messages to George Tetley (the then Marketing Services Manager) of the Gold Coast Bulletin and to councillors Robbins and Power the next day: Attachment 7. My message to George Tetley shows my desire not only to identify Gold Coast wide hot topics in order of priority, but more specifically to obtain a sample of opinion across individual council divisions to identify the unique local Divisional issues. I thought that it would be necessary to focus on assisting individual candidates in their campaigns, having clarified the boundaries for each division, and the issues that were specific to those areas. The issues listed were only my thoughts of what may become relevant during the election campaign, and were not a list of specific issues agreed to during the 10 December meeting.
- 15. The e-mail to Councillors Robbins and Power also mentions "Proposed meeting with Tony re establishment of the Trust Fund..." The understanding at the 10 December meeting as to funding of Quadrant's work was that individual councillors and candidates would not be paying for it rather, that it would be paid for by "donations from the business community". No more detailed discussion occurred as to how this would be managed but it was understood that I was to approach Mr Ray's lawyers (Tony Hickey from Hickey & Co.) to obtain advice. I did not know Mr Hickey at this stage although I recall that I may have met him once socially at golf.
- 16. As I was interested in ensuring that Quadrant would be paid in a legitimate and appropriate fashion I undertook to meet with Mr Hickey to ensure that appropriate arrangements were made in that regard. Ultimately this meeting took place on Wednesday 17 December 2005, with Tony Hickey and Brian Ray. As at 10 December, my focus was upon how Quadrant could present as a resource capable of assisting the candidates in question.

- 17. I note that for internal accounting convenience within Quadrant I initially called the trust fund the "Power-Robbins" trust account as they were two people that I had met with at that stage in relation to this new account.
- 18. My email of 11 December (Attachment 7) also refers to "Ted and Bob". This was a reference to two other sitting councillors, Ted Shepherd and Bob La Castra, who were mentioned at the 10 December meeting as councillors who might also be prepared to be involved in these discussions. At this stage I had not yet met Bob La Castra, but I had a long personal association with Ted Shepherd, including being involved on his then reelection campaign committee on a personal, unpaid basis.
- 19. At the conclusion of the meeting on 10 December it was proposed that a further meeting be held on 17 December 2003. However this meeting was ultimately brought forward to 16 December 2003 and held at the offices of Quadrant: see e-mail exchange <u>Attachment 8.</u>
- 20. I had no role in determining who would be attending the meeting proposed for 16 December. I understood that Councillors Robbins and Power were to organise the attendance of the candidates and that Quadrant might pitch to assist in their campaigns. In fact I ultimately sought, and obtained from Mr Power the list of attendees as well as some other information in preparation for that meeting which was to be held at Quadrant's offices: <a href="Attachment 8">Attachment 8</a>. I sought this information in advance of the meeting particularly the details of their divisional boundaries so that I could undertake some preparation of Quadrant's presentation of what we could do, for example by identifying the individual electoral issues facing each candidate attending the meeting. Of the people that I had been informed would be attending, I had previously only met Rob Molhoek. I did not know or even know of the other candidates.
- 21. In preparation for the meeting of 16 December 2003, I drafted a document to facilitate the presentation to the meeting: Attachment 9. From my several discussions to this point with Messrs Ray and Power and Ms Robbins I held the perception that what was needed was a group campaign and a co-ordinated ticket of some kind for the election of people who had common sense and who wanted to get on with the business of being responsible councillors. This perception i.e. of a group campaign persisted in my mind until this meeting of 16 December 2003.

22. I approached this meeting as being an opportunity to present the services that Quadrant could provide to them both collectively and individually.

#### Meeting of 16 December 2003

- 23. The meeting took place at the offices of Quadrant from about 5 pm until about 7.00 pm. My Diary for that day has a notation at 5pm "GCCC Candidates @ Q" recording this: Attachment 10. The people who were in attendance were David Power, Sue Robbins, Ted Shepherd ("the councillors") and Rob Molhoek, Roxanne Scott, Grant Pforr, his wife and campaign manager Liz Pforr, Greg Betts and Brian Rowe ("the candidates"). Although originally stated by me as attending, Bob La Castra did not in fact attend this meeting (I made this correction to the Chair of the CMC by facsimile on 11 October 2005). The first time that I met Bob was sometime later in January 2004 at Quadrant's offices. He was mentoring Roxanne Scott and assisting her in her campaign and I only ever spoke to him in that capacity.
- 24. I sensed that the candidates had not met each other previously or at least did not seem to know each other very well. I am unsure of whether there was any prior association between the councillors who were present and any of the candidates. I assumed that there had to have been some contact for them having been invited.
- 25. From the outset at this meeting David Power and Sue Robbins explained the nature of the assistance that they were seeking to facilitate through Quadrant. The said that their focus was ensuring that support be provided to candidates in their respective election campaigns so that those who were elected would take a sensible common sense approach to their duties as councillors. It carried with it the implicit endorsement that these councillors thought that these candidates would take such an approach if elected. Much of the focus of discussion was on returning dignity and decorum to the council chamber. There was no attempt made by anyone to seek to correlate views on any local government issue or decision.
- 26. When I was explaining what Quadrant could do and the range of services we could provide I referred to the document mentioned above which had noted my sense of what was needed in a co-ordinated campaign. Some of the attendees sought a copy of the document that I was referring to for the purposes of the discussion and I recall that I caused for my assistant to copy it for the people in the meeting. Included in this document were a number of issues that I had identified as local council issues. I had

prepared this list myself beforehand. I sought to conduct a preliminary assessment of the priority issues for local government generally and asked the individual councillors/candidates to note their own priorities on their copies of the document. I subsequently made a note of these priorities which indicated that the issues of water and transport were the 'top of mind' issues.

- 27. From my perspective there were two dimensions to the meeting: firstly determining whether or not the candidates wanted assistance with their campaigns; and if so, the level of assistance that Quadrant would provide.
- 28. Towards the conclusion of the meeting, and more as an aside, I made suggestions to David Power on the conduct of a co-ordinated group or collective campaign. David Power responded most emphatically that this was not a group ticket campaign of any kind. He said something like: "no mate, no, we are not running a ticket" and that "it has never been intended to be a ticket". He emphasised the need to preserve independence amongst councillors. He referred to the need for the return of propriety and dignity to the civic chamber. He said that the purpose of the assistance (by Quadrant) was to support candidates that appeared to be sensible and bring common sense to the council people existing councillors could work with. At this point, my preconception about these issues that I mentioned above and which had been the primary premise of Quadrant's presentation for that day, including my own briefing note, stopped there and then. It was at this point that my expectations of work required for individual candidates by Quadrant crystallised into the form it ultimately took. I will set that out below.
- 29. The meeting then focussed on what individual assistance could be provided by Quadrant to individual candidates. It was already apparent that some were far more significantly advanced than others in formulating and organising their respective campaigns.
- 30. There was also discussion about who would be paying Quadrant's fees. I explained that as far as I understood the arrangements none of the candidates would be meeting our accounts directly. It was explained either by Mr Power or myself (I just do not recall who) that a trust fund would be established by a law firm to administer donations to ensure anonymity to the contributions and accountability and compliance with legislative requirements, and that Quadrant's fees would be met from this trust fund. Although I was also aware that donors were to be organised by Brian Ray, and that councillors Power and Robbins knew this also, I did not disclose Mr Ray's involvement to anyone at the meeting

and my recollection is that no-one else did. I recall informing the candidates that Quadrant would produce individual invoices for expenditures for each candidate, but that all invoices would be paid for out of the trust fund.

- 31. Individual candidates had different levels of capacity in the formulation of their respective campaigns. They also expressed different levels of interest in the services offered by Quadrant. This is my best recollection in this respect:
  - 31.1. Each of the existing councillors (other than Ted Shepherd) sought no assistance in their respective campaigns and it was not, and in fact never, envisaged that Quadrant would provide any services to them at all.
  - 31.2. I had a prior association with Ted Shepherd well before Quadrant's involvement in these meetings initiated by Mr Ray. For example, I was on Ted's campaign committee for re-election and had been involved at a minor level in his 2000 campaign handing out how to vote cards. I continued to work on Ted's campaign committee and Quadrant ultimately formally assisted Mr Shepherd in his 2004 campaign. He paid for this directly out of his own funds. This retainer had nothing to do with the arrangements arising out of the Ray initiative.
  - 31.3. Rob Molhoek appeared very organised and advanced in his campaign organisation and indicated that he needed very little assistance from Quadrant. He was interested in a financial contribution to his campaign and that appeared to be his primary focus. I did subsequently meet him over a cup of coffee, at his request, and looked over his campaign plans; I made some suggestions and complemented him on his campaign. Other than these comments Quadrant provided nothing else by way of services to him.
  - 31.4. Similarly, Brian Rowe's campaign was largely complete by that stage and he indicated that he did not need any assistance from Quadrant either and no services were provided to him, other than some minor art work alterations to a colour brochure he was about to print.
  - 31.5. The remaining three candidates, Grant Pforr, Roxanne Scott and Greg Betts each sought and ultimately received support and advice from Quadrant in relation to their individual election campaigns. <u>Attachment 11</u> includes my notes documenting work

on these individual campaigns. In the course of work done on Roxanne Scott's campaign I advised her then campaign manager, Stuart Hill, not to run a significant negative campaign against the incumbent councillor Dawn Critchlow as our focus for Roxanne was on positive campaigning. I advised Mr Hill that he should resign as campaign manager for Roxanne Scott and establish an independent entity through which to run this alternative campaign — and this became known as the Southport Citizens for Change.

#### Meeting of 17 December 2003

- 32. Following the meeting of 16 December 2003, I met with Brian Ray and Tony Hickey on 17 December at 8.30am in Brian's office (see Attachment 12 diary note). The purpose of the meeting was to discuss the formalisation of arrangements for funding the establishment of the trust fund. Tony and Brian had a list of possible donors and it was agreed that it was their role to secure the funding. The outcomes of the meeting were:
  - 32.1. Hickey was to draw up the trust arrangements.
  - 32.2. Hickey, Ray and Power would be responsible for the selection of, and follow up of, donors.
  - 32.3. There would be anonymity as to who the donors to this fund were.
- 33. Other than a suggestion which I made to a personal friend about the possibility of her company contributing to this fund, neither Quadrant nor I had a further role in respect of funding, organisation of the trust fund or administration of it.
- 34. As I have said from that point, Quadrant worked specifically on the individual campaigns of candidates Pforr, Betts and Scott. Following the meeting on 16 December 2003, I organised a further meeting for 8.30am on Thursday 8 January 2004 (see <u>Attachment 13</u>). This meeting was attended by Grant Pforr and his wife; Greg Betts; Roxanne Scott and myself.
- 35. In about April 2004, Quadrant produced detailed and separate invoices for the services provided to each of these candidates for the purposes of their final electoral returns. These are Attachments 14, 15 and 16.
- 36. On January 30 2004, I became aware that Lionel Barden had agreed to give his name to the fund. I had no role in his selection but I did subsequently meet him to show him the

accounts that we had rendered. After his approval of these accounts, payments were received from Hickey's trust account from time to time.

- 37. Attachment 17 is a breakdown of monies received by Quadrant in relation to the council election campaign.
- 38. During the course of discussions outlined above, my clear understanding was that candidates were required to declare that they had received funds through a trust account, and to name the trust account. However, that there was no requirement therefore to name the donors to the trust account and that they would remain anonymous. I would have gained this understanding through my discussions with Brian Ray, Tony Hickey and David Power. If queried by the candidates on their obligations to disclose funding sources, I would have advised them in accordance with my understanding of their obligations at that time.

All the facts and circumstances above deposed to are within my own knowledge and belief save such as are deposed to from information only and my means of knowledge and sources of information appear on the face of this my affidavit.

Sorry about the delay but I wanted to canvas a couple of extra opinions before responding. Our objective is to obtain a representative sample of opinion across individual council Divisions or the regional/suburban areas that most closely reflect them.

I have a copy of the recently restructured boundaries coming, so we can assess areas.

From a questionnaire point of view, there are three objectives. One to establish what are the four primary Gold Coast wide hot topics in order of priority, what if any unique local Divisional issues exist in a particular suburb, and thirdly "Can you name your local GC City Councillor".

Topics are in no particular order:

- Environment
- Growth Management






