- (c) the dealings between you or Hickey Lawyers and Paul Brinsmead, Graham Staerk, David Power, Ray Hackwood, Ron Clarke, Robert La Castra, Edward (Ted) Shepherd, Jan Grew, Sue Robbins, Grant Pforr, Brian Rowe, Robert Molhoek, Roxanne Scott and Greg Betts in relation to the Gold Coast City Council elections of 27 March 2004.
- (d) your dealings with, and knowledge of: the Lionel Barden Commonsense Campaign Fund; the Lionel Barden Common Sense Trust; the Common Sense Trust; the Lionel Barden Trust; the Power and Robbins Trust; or any person or entity associated with the aforementioned persons or entities in relation to the Gold Coast City Council elections of 27 March 2004.

INFORMATION TO ADDRESSEE

GENERALLY

YOU MUST COMPLY WITH THIS NOTICE

Failure to comply with this notice, without reasonable excuse, constitutes an offence which carries a maximum penalty of 85 penalty units or 1 year's imprisonment.

An offence is not committed if the information, document or thing—

is **subject to privilege**;

OR

is a **secret process of manufacture** applied by you solely for a lawful purpose.

Privilege, in the context of a misconduct investigation, means -

- (i) legal professional privilege; or
- (ii) public interest immunity; or
- (iii) parliamentary privilege

and includes a claim on the ground of confidentiality. "Confidentiality" means a ground recognised at law that giving an answer, or disclosing a communication or document, would be a breach of an oath taken or statutory or commercial obligation or restriction to maintain secrecy.

By complying with this notice, **YOU DO NOT**—

contravene a provision of an Act or law imposing a statutory or commercial obligation or restriction to maintain secrecy in relation to the information, document, or thing;

OR

incur any civil liability in relation to the information, document or thing.

SHOULD YOU HAVE A CLAIM OF PRIVILEGE

The commission officer is to consider the claim. The commission officer may withdraw the requirement in relation to which the claim is made **OR** may advise you that you may apply to or be required to attend before the Supreme Court to establish the privilege under section 196 of the *Crime and Misconduct Act 2001* (Q).

(b) the end of 3 court days after the day on which the document or thing is given to the registrar, if an application has not been made under paragraph (a);

OR

(c) the registrar is told by the person and the commission representative that agreement has been reached on the disposal of the sealed evidence.

If an application is made to a Supreme Court, the Registrar is to dispose of the sealed evidence in the way ordered by the judge.

If an application is not made by the end of 3 court days after the day on which the document or thing is given to the Registrar, the Registrar is to return the sealed evidence to you.

If you and the commission representative give the registrar notice that an agreement on the disposal of the sealed evidence has been reached, the Registrar is to dispose of the sealed evidence in the way agreed.

Back on Friday the 26th December 2003 the Gold Coast Bulletin ran a front page article on a "power bloc" made up of Wayne Skuthorpe, Don Magin, Guy Jones, Linda Browne Irene Wareing, Dr. Karen Coates supported by Peter Young and Dawn Crichlow.

Many members of the Combined Chamber of Commerce of which I was one were concerned about the impact the policies espoused by the "bloc" would have on the economy and future direction of the Gold Coast if they were successful in obtaining a controlling voting bloc. We discussed at a number of Combined Chamber meetings our involvement in the upcoming Council elections to counter what appeared to be a well funded political machine which had been set up by the so called "bloc".

By the end of December I had retired from the Robina Chamber Presidency as my business interests were all now at Coolangatta. I had no further involvement in the Combined Chamber decisions.

Once the election campaign commenced I was invited to a number of meet-the-candidates meetings at various chamber venues. I continued to be concerned that there seemed to be a well organised and well funded group of candidates whose policies would in my view be detrimental to the continued economic development of the Gold Coast. I discussed my concerns with David Power and suggested that he make sure he had the resources to properly conduct his campaign.

On or about the last week of January I was approached by David Power and Sue Robbins to act as a trustee of a Trust account which people from a broad business spectrum could donate funds to support a counter group of like minded candidates who would make positive and cohesive decisions for the economic development of the City. This approach was unexpected and unsolicited on my part.

I understand that I was asked to do this because of:

- 1) My long term involvement in the Cities economic development strategies through REDAC.
- 2) My support for Council and the City in representation including the Melbourne-Sydney and the two Canberra trips.
- 3) My business could not gain from Council decisions. Being based at Gold Coast airport my business did not come under council jurisdiction.
- 4) I no longer represented any business group

The Trust account was I understand put in place to displace any later implication of influence over members of Council which might arise from direct donations to candidates. The candidates were not aware of sources of donations to the Trust and the donors had no direct access to candidates by way of funding. It was our aim to reduce the opportunity for or the perception of influence as a result of donations. Even I was not aware of the full donor list until after the election was over.

Hickey Lawyers had been appointed to handle the administration of the Fund and all of the monies were handled by them and as far as I know (and certainly where I was directly involved) money was paid from the Fund against invoices submitted by professional and commercial companies involved in the direct servicing, production of printing and media etc.

I produced a letter of appointment to Quadrant. I signed off on Quadrant invoices for the services provided again to make sure all was above board.

I did not know the total amount of money which was received until after the election when I received and approved the Form 3 (return of gifts) for lodgement under the requirements of Local Government Act. I gave a general authorisation to Hickey Lawyers regarding the way in which the Fund was to be disbursed and specific approval in relation to Quadrant but I did not sign any cheques.

As far as I am aware from my own knowledge, there were no funds provided to any candidate directly.

I was not paid anything for my involvement with the Fund. I did not personally donate or contribute any money to the Fund.

My initial understanding was that the donors would remain anonymous but after receiving further legal advice I learned that it was necessary to disclose the individual donor's names and the amount of their funding. I then organised for this to be done and this information was disclosed. I did not and as far as I am aware no one else asked for donations on the basis that the fund was secret in any way and the details of the donor's would not be disclosed. This was not an issue as far as I was concerned and I had no hesitation in arranging for the preparation of the amended return once I was made aware of the requirements.

On the 11th of April 2005 Hickey Lawyers received a letter from the CMC requesting information and files referring to the Lionel Barden Trust which I authorised them to pass over the documents. (See attachment(A))

Since the election I have been harassed and defamed by a number of people including some councillors with innuendo and down right lies well supported by a one sided and hostile media. This has been so serious that it has badly damaged my business activities and my position in the community. I therefore welcome this investigation.

 - 1c I include letter of appointment (attachment (B) and payment instructions marked (attachment (C) which I made to Hickey Lawyers.
 - 1d Quadrant requested payments, Their address is
East Quay Corporate Park 34 Glenferrie Drive Robina QLD.4226
 - 1e Please note previous attachments
 - 1f I received no instruction or request at any time from candidates.
 - 1g I did not have any direct involvement with the receipt or payment of the monies which I left to Hickey Lawyers in accordance with the instructions referred to earlier.
2. I attach the following documents as requested include:
- Quadrant copies of invoices and statements (attachment (D)
 - Copy of Form 3 Return of Gifts as submitted (attachment (E).
 - Letter requesting details for return which was later overturned and the donors named in the official document. (attachment (F)
3. I refer to the attached letter. I had many conversations with Quadrant but only in line with work carried out by them. I had some conversations with some candidates, with David Power and Sue Robbins, with Tony Hickey but only in line with normal campaign activities.
- 4a Please note previous information as advised and supplied.
- 4b/c I have explained my dealings with Hickey lawyers, David Power and Sue Robbins previously. I do not know nor had any dealings with Paul Brinsmead. Graeme Staerk telephoned me once during the campaign and I advised him that I had no comment and ceased the conversation. I knew Ray Hackwood but had no dealings with him during the period. I knew Bob la Castra and would have spoken to him but on general matters only. I handed out how to vote cards for Ted Shepherd and Jan Grew on election day. I had no dealings with Ron Clarke. I met Grant Pforr, Roxanne Scott and Brian Rowe once during the campaign when I coached some of the candidates on public relations aspects of operating polling booths on election days. I knew Rob Molhoek well but did not meet during the campaign. I met Gregg Betts for the first time after he was elected.
- 4d I believe my original statement answers this question.

I do not have many primary records or documents relating to the Fund because those are held by Hickey Lawyers and therefore the information I am providing is to the best of my knowledge.

To assist the CMC in the:


- performance of its misconduct function under the *Crime and Misconduct Act 2001* (the Act) and

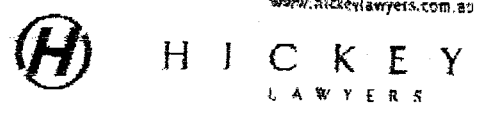

As far as their request for a copy of the terms of the trust, the answer is that there is no trust document.

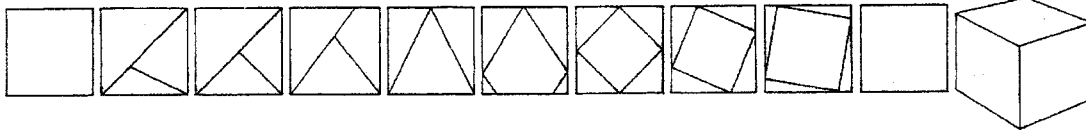
