> I have unfortunately had to delete lots of names and huge amounts of detail from
this version of the document so as to make the best attempt to protect myself from any
defamation charges. This diminishes the quality of the document somewhat, but adds
weight to my claim that the Minister needs to call an enquiry and have these matters
(and others) brought out into the open - without the fear of strategic defamation
suits to shut people up.
> The section most heavily edited is principally about Councillors voting on matters
involving developers who contributed to the trust fund. The real facts in that section
