Karel Alexander WEIMAR states:-

1. I am a Certified Practicing Accountant (CPA) and I hold a Bachelor of Business degree from the Queensland Institute of Technology (1985) and a Master of Commerce degree from Griffith University (2000). I am a member of CPA Australia and I have been a CPA since 1998.
  2. I am a Principal Financial Investigator employed by the Crime division of the Crime and Misconduct Commission (CMC) and I have been employed by the Commission as a Financial Investigator for seven years.
  3. In August 2005, I was assigned to an investigation into complaints relating to the Gold Coast City Council.
- As part of that investigation, I have examined documents provided under Notice to Discover by both Hickey Lawyers and Mandra Pty Ltd trading as Quadrant.
5. Based on the information contained in the account statements and the invoices provided by both Hickey Lawyers and Mandra Pty Ltd trading as Quadrant, I have previously prepared a schedule which reconstructed the activity on the accounts for candidates Pforr, Rowe, Scott, Betts, Shepherd and the Southport Citizens for Change. This schedule was attached to my witness statement dated 10 October 2005. I divided that schedule into those accounts paid from funds held in the trust accounts operated by

Hickey lawyers and the accounts paid from funds held in the campaign accounts of Grant Pforr and Ted Shepherd.

6. The schedule produced on 10 October 2005 was incomplete in that not all payments to Quadrant had been accounted for in the documents provided.
7. On 09 October 2005, in response to a CMC request for further information to complete the reconciliation of the candidate accounts, Chris Morgan faxed further information to the CMC which accounted for all payments made to Quadrant.
8. Using the further documents provided by Quadrant Based, I have prepared a further schedule which reconstructs all of the activity on the accounts for each of the candidates and the Southport Citizens for Change. Changes to my initial schedule are in bold and italics.
9. This spreadsheet entitled "Quadrant Invoices – final reconciliation" is attached to this statement.




