## Statement of Anthony David Scott

I, Anthony David Scott, d in the State of Queensland, make oath and say as follows:

- 1. I refer to my statement, dated 10 November 2005, tendered in these proceedings.
- 2. I refer to paragraph 7 of that statement where I stated that from my own recollection I did not believe that I attended a meeting between Chris Morgan, Brian Ray, Councillors Robbins and Power on 3 December 2003. I also concede that I have re stated this in my evidence before the Commission so far.
- I have since checked my diary and have discovered that there is in fact a diary entry for 3 3. December 2003, again contrary to my evidence yesterday, as follows "11.30am TS/CM -Brian Ray". My diary for December 2003 is attached and marked Exhibit 1. The initials TS are commonly used to refer to myself, Tony Scott.
- 4. Despite this diary entry I have no memory of attending this meeting or of what happened at the meeting.
- 5. However I do now accept that I probably was at this meeting. I can infer this by the fact that my diary would not have included that entry had I not been at that meeting. Although there is a possibility that it simply records that this meeting was scheduled. I simply have no memory of attending the meeting at all.

- 6. I believe that at the time of making my previous statement I was confusing the meeting on 3 December with the meeting held on 10 December between Chris Morgan, Brian Ray, Councillors Robbins and Power. My diary entry for 10 December is as follows: "9.30am 9.30am - CM with Brian Ray / Sue Robbins / David Powers @ Q". Despite looking at my diary again I still do not believe that I attended any such meeting.
- 7. I certainly have no recollection of any conversations had at these meetings. The only knowledge I have of these meetings is that they were the original meetings between Quadrant and Mr Brian Ray in the terms of Quadrant putting together an advertising budget to assist candidates to run in the then upcoming March 2004 Gold Coast City Council elections.

All the facts and circumstances above deposed to are within my own knowledge and belief save such as are deposed to from information only and my means of knowledge and sources of information appear on the face of this my affidavit.
